Panel on Transport Special Meeting on 31 August 2018

Supplementary Information

At the special meeting of the Panel on Transport held on 31 August 2018, some Members requested the Government to provide supplementary information on issues relating to the steel works and associated remedial measures at the diagram walls and platform slabs of Hung Hom Station Extension under the Shatin to Central Link (SCL) project. Our replies are as follows:

(a) information presented by the Secretary for Transport and Housing and the Acting Director of Highways at this meeting about the problem of honeycomb concrete

In his opening speech, the Secretary for Transport and Housing presented the following information about the problem of honeycomb concrete:-

"Recently, Highways Department has revealed an incident involving the spalling of concrete and even the exposure of reinforcement bars at part of the platform slab of the Hung Hom Station Extension via a new standing item in the agenda for the Project Supervision Committee meeting which discussed the data in the Non-conforming Reports issued by the MTRCL to the contractors. Later, I will ask the Acting Director of Highways and Deputy Director of Buildings to supplement the information about the incident."

Regarding the information presented by the Acting Director of Highways at this meeting in relation to the problem of honeycomb concrete, please refer to **Enclosure (1)**.

(b) details of the sub-contractors responsible for carrying out the concrete pouring works in the bays/areas where the problem of honeycomb concrete was identified

The problem of honeycomb concrete was identified at the soffit of the East West Line ("EWL") platform slab of Areas B, C1 and C2. The sub-contractor for concreting works for Hung Hom Station Extension EWL slab is China Technology Corporation Limited, except that, for Bay No. 1875 of Area C1, the sub-contractor for concreting works is Richwell Civil Engineering Limited.

(c) details of works projects [except Shatin to Central Link project] funded by public monies and under construction by Leighton Contractors (Asia) Limited

Enclosure (1): Information presented by the Acting Director of Highways at this meeting about the problem of honeycomb concrete

At the Shatin to Central Link Project Supervision Committee meeting held on 28 August this year (2018), MTRCL mentioned that there were concrete quality problems at the soffit of part of the East West Line ("EWL") platform slab at Hung Hom Station Extension. What MTRCL was referring to was the phenomenon of honeycombing that occurred in the concrete at the soffit of part of the platform slab.

The Government then asked for a site visit to understand the incident in detail. Building Department ("BD") carried out on-site inspection in the morning of 29 August and requested the MTRCL to submit an investigation report. In the afternoon of the same day, the MTRCL provided HyD with a total of three non-conformance reports issued to the contractor between 17 and 22 August regarding concreting works of the platform slab; and requested the contractor to remove substandard concrete.

Highways Department ("HyD") was very concerned about the incident and asked MTRCL on 29 August to clarify whether there was safety problem at the EWL platform slab. HyD and its Monitoring and Verification consultant also inspected the site on 30 August. It was found at multiple locations at the soffit of the EWL platform slab in Areas B, C1 and C2 that after the removal of concrete, there was honeycombing at the concrete surface. On the same day, the HyD immediately issued a letter requesting MTRCL: (i) to check whether the platform slab is fraught with safety problem, and whether workers can continue working on it; (ii) to take immediate action that eliminates safety hazards; and (iii) to review the quality of concrete at the platform slab comprehensively, and submit an investigation report and propose remedial works as soon as possible for the BD's consideration.
