# Import and Export Ordinance (Chapter 60)

# Import and Export (Electronic Cargo Information) (Amendment) Regulation 2017

#### **INTRODUCTION**

At the meeting of the Executive Council on 26 September 2017, the Council ADVISED and the Chief Executive ORDERED that the Import and Export (Electronic Cargo Information) (Amendment) Regulation 2017 ("Amendment Regulation") (at <u>Annex</u>), should be made under section 31 of the Import and Export Ordinance (Cap. 60) ("Ordinance"). The Amendment Regulation enables the operation of the Road Cargo System ("ROCARS") to be extended to the Hong Kong-Zhuhai-Macao Bridge ("HZMB") Hong Kong Port ("HKP").

#### **JUSTIFICATIONS**

2. The ROCARS is an electronic advance cargo information system implemented since 2010 for customs clearance of road cargoes. Its coverage and operational details are prescribed in the Import and Export (Electronic Cargo Information) Regulation (Cap. 60L) ("Regulation"). Schedule 2 to the Regulation sets out the locations to which ROCARS applies. At present, these locations are the Lok Ma Chau Boundary Control Point ("BCP"), Man Kam To BCP, Sha Tau Kok BCP and the Clearance Area of the Shenzhen Bay Port Hong Kong Port Area.

- 3. The HZMB is the first cross-boundary land link connecting Guangdong, Hong Kong and Macao. The HZMB HKP will be a new location for customs clearance of road cargoes in Hong Kong. To pave way for the commissioning of HZMB HKP, Schedule 2 to the Regulation should be amended to include the HZMB HKP, so as to enable the extension of ROCARS to that location. This amendment will allow the Commissioner of Customs and Excise<sup>1</sup> to designate an area within HZMB HKP as customs clearance point for the purpose of ROCARS operation pursuant to section 13 of the Regulation.
- 4. According to the current progress, the Highways Department's assessment is that the Hong Kong Section of the HZMB will achieve readiness for commissioning by the end of 2017.

#### THE PROPOSAL

5. To enable the ROCARS operation to be extended to the HZMB HKP, the Amendment Regulation should be made to include the HZMB HKP in Schedule 2 to the Regulation pursuant to section 31 of the Ordinance.

#### THE AMENDMENT REGULATION

6. The Amendment Regulation will update Schedule 2 to the Regulation by adding HZMB HKP to the list of locations to which ROCARS applies.

## IMPLICATIONS OF THE PROPOSAL

8. The proposal is in conformity with the Basic Law, including the provisions concerning human rights. It will not affect the current binding effect of the Ordinance. The proposed amendment is technical in nature, and has no financial, civil service, economic, competition, productivity, environmental, sustainability, family or gender implications.

9. The Legislative Council Panel on Commerce and Industry noted the information paper provided by the Government in July 2017 on the proposed technical amendment without comments.

## **Explanatory Note**

This Regulation adds the Hong Kong-Zhuhai-Macao Bridge Hong Kong Port (*Hong Kong Port*) to Schedule 2 to the Import and Export (Electronic Cargo Information) Regulation (Cap. 60 sub. leg. L) so that the Commissioner of Customs and Excise, or a Deputy or Assistant Commissioner of Customs and Excise, may designate an area within the Hong Kong Port as a customs clearance point.
