# HOSPITAL AUTHORITY ORDINANCE (AMENDMENT OF SCHEDULE 1) ORDER 2018

#### **INTRODUCTION**

At the meeting of the Executive Council on 23 January 2018, the Council ADVISED and the Acting Chief Executive ORDERED that the Hospital Authority Ordinance (Amendment of Schedule 1) Order 2018 (the Order), at **Annex A**, should be made under section 20 of the Hospital Authority Ordinance (Cap. 113) (the Ordinance), to accord Hong Kong Children's Hospital (HKCH) proper legal status before it comes into operation.

#### JUSTIFICATIONS

2. Schedule 1 to the Ordinance (reproduced at **Annex B**) lists out the hospitals the management and control of which may be vested in the Hospital Authority (HA) under agreements with the Government. HKCH is a newly built hospital and thus has not been listed in Schedule 1.

3. HKCH will serve as a tertiary specialist hospital for management of complex paediatric cases, working closely with the existing 13 paediatric departments in HA hospitals through a hub-and-spoke model to form a coordinated service network. It will have a total planned capacity of 468 in-patient and day-patient beds, operating theatres, ambulatory surgery/day procedure centre, integrated rehabilitation centre and child development assessment services, children recreation and play therapy areas, family rest area, as well as research and training facilities. Through the concentration of cases of complex,

serious and uncommon diseases among children, as well as the pooling of medical expertise, advanced technology and resources, HKCH is aimed to enhance the quality of paediatric care in Hong Kong and provide a platform to facilitate research development and professional training.

4. HKCH will be managed and operated by HA under an agreement between the Government and HA, and will commence operation in the fourth quarter of 2018. To accord HKCH proper legal status to enable the establishment of its Hospital Governing Committee<sup>1</sup> before it comes into operation, we propose to amend Schedule 1 to the Ordinance by adding HKCH as a prescribed hospital under the Ordinance the management and control of which may be vested in HA under an agreement with the Government.

5. Under section 20 of the Ordinance<sup>2</sup>, the Chief Executive may by order amend Schedule 1.

## THE ORDER

6. **Section 2** of the Order amends Schedule 1 to the Ordinance by adding HKCH to the list of hospitals the management and control of which may be vested in HA under agreements with the Government.

# IMPLICATIONS OF THE PROPOSAL

8. The proposal is in conformity with the Basic Law, including the provisions concerning human rights. It will not affect the current binding effect of the Ordinance. It has no economic, civil service, environmental or sustainability implications. The proposal also has no financial implications as the Government's annual subvention to HA is an all-inclusive one that has incorporated financial resources to enable the latter to provide public healthcare services through all of its hospitals, including HKCH which is to be newly commissioned. On family and gender implications, the establishment of HKCH would enhance the quality of paediatric care in Hong Kong and enhance support to families and carers (especially the mothers) in taking care of children.

# PUBLIC CONSULTATION

9 The proposal to include HKCH as a prescribed hospital under the Ordinance is procedural in nature and public consultation specifically on it is not necessary. HA, on the other hand, has been working hand-in-hand with relevant stakeholders in universities. non-governmental organisations, patient groups, etc. to facilitate the planning and commissioning of HKCH. The Legislative Council Panel on Health Services was also updated on the progress of development of HKCH at its meeting held on 15 June 2015. HA tentatively plans to brief the Kowloon City District Council on the services of HKCH in March 2018.
