# IMMIGRATION SERVICE (DESIGNATED PLACES) (AMENDMENT) ORDER 2018

### INTRODUCTION

The Secretary for Security has made the Immigration (Places of Detention) (Amendment) Order 2018, at Annex A, and the Immigration Service (Designated Places) (Amendment) Order 2018, at **Annex B** (the Amendment Orders) under section 35(1) of the Immigration Ordinance (Chapter 115) and section 13A(9) of the Immigration Service Ordinance (Chapter 331) respectively in order to set detention quarters commissioning up upon of the Guangzhou-Shenzhen-Hong Kong Express Rail Link (XRL) West Kowloon Station (WKS) Port (WKS Port) for use by the Immigration Department (ImmD) in its daily immigration control and law enforcement.

# **JUSTIFICATIONS**

2. The WKS is a station in the Hong Kong Section of the XRL. It will provide clearance facilities for cross-boundary passengers using the XRL, which is a mega cross-boundary railway infrastructure project connecting Hong Kong with the major Mainland cities via the national high-speed rail network. The Hong Kong Section of the XRL is anticipated to commission in September 2018.

3. At present, ImmD has set up detention quarters in such control points as the Hong Kong International Airport, Lok Ma Chau Spur Line and the Hong Kong Port Area of Shenzhen Bay Port. There will be the same arrangement in the Hong Kong Port of the Hong Kong-Zhuhai-Macao Bridge to be established. Similarly, ImmD needs to set up detention quarters at the WKS Port for its daily immigration control and law enforcement upon commissioning of the WKS Port. The detention quarters concerned will be set up in the area under the jurisdiction of the Hong Kong Special Administrative Region (HKSAR) and only be used by the ImmD of the HKSAR. For this purpose, Schedule 3 of the Immigration (Places of Detention) Order (Chapter 115B) and the Schedule to the Immigration Service (Designated Places) Order (Chapter 331B) have to be amended accordingly.

### AMENDMENT ORDERS

- 4. Section 1 of the respective Amendment Orders at **Annex A** and **Annex B** provides that the Amendment Orders would come into operation on the commencement date of the Ordinance enacted by the Legislative Council through the passage, with or without amendment, of the Guangzhou-Shenzhen-Hong Kong Express Rail Link (Co-location) Bill<sup>1</sup>, in order to meet ImmD's needs to carry out daily immigration control and law enforcement upon commissioning of the WKS Port.
- 5. Section 2 of the Immigration (Places of Detention) (Amendment) Order 2018 amends Schedule 3 of the Immigration (Places of Detention) Order (Chapter 115B) by adding "[t]he area within the West Kowloon Station of the Guangzhou-Shenzhen-Hong Kong Express Rail Link (other than the West Kowloon Station Mainland Port Area) that is set aside as detention quarters for use by the Immigration Department". Likewise, Section 2 of the Immigration Service (Designated Places) (Amendment) Order 2018 so amends the Schedule to the Immigration Service (Designated Places) Order (Chapter 331B).

# IMPLICATIONS OF THE PROPOSALS

7. The amendments are simply to add provisions for setup of detention quarters at the WKS Port. The proposals are in conformity with the Basic Law, including the provisions concerning human rights. They do not affect the current binding effect of the Immigration Ordinance (Chapter 115) and the Immigration Service Ordinance (Chapter 331). They have no civil service, economic, competition, productivity, environmental, sustainability, family or gender implications. ImmD has secured the manpower resources required for undertaking immigration control functions upon commissioning of the WKS Port.

8. The amendments are technical in nature. No public consultation has been arranged. We issued this brief on 30 May 2018.

# Immigration (Places of Detention) (Amendment) Order 2018

(Made by the Secretary for Security under section 35(1) of the Immigration Ordinance (Cap. 115))

#### 1. Commencement
