## **Explanatory Note**

These Rules amend the Practising Certificate (Solicitors) Rules (Cap. 159 sub. leg. L) (*principal Rules*) to—

- (a) increase the fee payable for an application for a practising certificate for any practice year beginning on or after 1 January 2019 from \$5,000 to \$6,500; and
- (b) stipulate a bilingual format for a practising certificate in Form 2 in the Schedule to the principal Rules, so that both English and Chinese versions can be printed on the same certificate.
