E-cigarettes can contain harmful and potentially harmful chemicals, including nicotine; ultrafine particles that can be inhaled deep into the lungs; flavoring such diacetyl, a chemical linked to a serious lung disease; volatile organic compounds such as benzene, which is found in car exhaust; and heavy metals, such as nickel, tin, and lead. These chemicals will harm the body in the long term. The government should take step by step actions to end this phenomenon, first banning new cigarette products, then formulate a way to ban cigarettes from Hong Kong.
