Dear Legislative Council Members.

I am a tobacco researcher with the Washington State Department of Health, who has spent a number of years in Hong Kong. The views I express below are my own and not the government agency that I work for, but I would like to strongly urge members of Hong Kong's LegCo to pass the Smoking (Public Health) (Amendment) Bill 2019, that prohibits the import, manufacture, sale, distribution and advertisement of alternative smoking products, including e-cigarettes, heat-not-burn tobacco products and herbal cigarettes.

Hong Kong has a wonderful opportunity to prevent the tobacco and nicotine addiction of children, and thus save tens of thousands of its citizens from debilitating smoking-related diseases and premature death. We in the United States have missed that opportunity, as e-cigarettes, heat-not-burn and other alternative smoking products are readily available to children here. The use of these products has grown exponentially in recent years, eroding the steady gains that were previously made in nearly all states against the consumption of tobacco. Many twelve and thirteen-year-old children in my daughter's middle school in Washington State smoke sweet-flavored tobacco and nicotine products, and it is probable that most will grow up to be lifetime smokers of either combustible cigarettes, e-cigarettes, or both.

In spite of widespread false advertising by the tobacco industry, the United States Food and Drug Administration (FDA) does not approved IQOS as modified risk products, and the FDA's scientific panel in January 2018 voted that IQOS is unlikely to pose less risks to health. Do not accept the false claims of Big Tobacco that vaping products are a healthy alternative to combustible cigarettes, and that they are doing Hong Kong citizens a public service by offering different forms of toxic alternatives. E-cigarettes, heat-not-burn tobacco products and the like exist to cause and perpetuate addiction, to enable Big Tobacco to continue making massive profits at the expense of the health of people in Hong Kong and other places throughout the world.

I strongly urge Hong Kong's LegCo to take the opportunity that we in the United States have not had, to be an example to other societies such as the U.S., and pass the Smoking (Public Health) (Amendment) Bill 2019. Future generations in Hong Kong and elsewhere in the world will thank you for your wisdom and foresight.

全港商會多年來凝聚香港營商力量,致力貢獻社會,並維護香港大眾利益,協助香港未來發展。我們全力支香港持經濟及社會的整體的可持續發展,包括推動長遠和有效的共公衞生政策。

控煙工作能保障公眾健康,促進社會的生產力,減輕社會醫療負擔,確保香港能夠得以發展,因此本會一直都深表支持,並向會員推廣健康生活,鼓勵吸煙人士戒煙。本會認為另類吸煙產品的流行會為香港社會帶來負面影響,因此,本會支持政府立法禁止進口、製造、售賣、分發和宣傳另類吸煙產品。

香港商會一向實事求是,採納值得信賴的科學證據。既然這些另類吸煙產品和傳統煙一樣有害,即會對社會帶來人命及經濟損失,為社會可持續發展,我們一定支持全面禁止這些另類吸煙產品。

香港一直享有「購物天堂」之美譽,商店種類包羅萬有,貨品質素有保證。不單止親身到零售點消費,網上購物亦成為香港市民的日常生活習慣。可惜,近年電子煙、加熱煙等另類煙產品流入香港市場,煙草製造商更以以下不良手法誤導消費者:

### 響起醫號防止煙害「疫情」<u>蔓延</u> 支持全面禁止另類吸煙產品

西貢區工商業聯合會由一群工商界的社會賢達及專業人士所組成,以「結聚俊賢,同興經貿」為宗旨,以達到團結及凝聚各界,為香港的經濟發展和繁榮穩定作出積極貢獻。本會對於政府提出的「全面禁止另類吸煙產品」有以下意見:

本會早就關注電子煙及加熱非燃燒煙草製品等另類吸煙產品已於全球大行其道,在短時間內成功吸引了大量人士使用,情況猶如疫情般嚴重。就以美國為例,使用電子煙的高中生人數在 2017 至 2018 年間大幅增加了近 80%,高達300 萬人,成為年青人最主要的吸煙途徑。去年本港亦有團體進行過問卷調查,發現每 10 個年青人中,有 3 個對電子煙表示有興趣。這次數據足以響起警號,顯示出年青人接受電子煙的程度比例甚高。許多會員擔心此風氣會因為另類煙草產品正規化而迅速於香港蔓延,故此強調政府應該盡快實行「全面禁止另類吸煙產品」而非「立法規管」。

這些另類吸煙產品的宣傳手法層出不窮,以時尚造型、五花八門的口味、有助戒煙、不易使人上癮、無二手煙煙害等等來包裝,吸引市民跌入陷阱,成為煙民,損害健康。首先,所有形形色色、林林總總的煙草產品都是有害的。愈來愈多國際研究指出電子煙含有多種危害而且成份不明的物質,電子煙及加熱煙亦被驗出致癌物,例如:甲醛及多環芳香烴(PAHs)。亦有研究發現對比非吸煙者,每天吸食電子煙增加心肌梗塞風險近一倍,如同時吸食電子煙及傳統煙,心肌梗塞風險更比常人高出 4.62 倍。電子煙中的重金屬亦會加速肝腎衰退,是一件非常危險的工具。

另外,加熱煙、電子煙等等的吸煙產品所含有尼古丁、焦油成份與傳統煙相若,亦會產生二、三手煙的問題,絕對不是煙草商所提及比傳統煙遺害較少。當中市民會誤以為新煙草產品無煙味,而減低對二手煙的警覺性,忽略吸煙會為身邊人士所帶來的健康風險。

鑑於坊間對這些另類吸煙產品存在誤解及被熱捧為潮流玩意,低估產品對身體的傷害,以致迅速風靡於年青人市場,誘惑非吸煙人士吸食第一口煙。根據報章報導,本港竟然有六、七歲的兒童公然於公眾場所吸食電子煙,所以立法修例不能一拖再拖,徹底杜絕電子煙及加熱非燃燒煙草製品等另類吸煙產品方為上策。

李氏宗親會致力培養青少年繼承和發揚華族傳統文化,將把李氏精神發揚發光,造福香港。自創會以來,一直支持政府衞生及控煙的工作。在控煙道路幾十年來,全因官商民三方協作,時刻嚴肅檢討控煙政策保障公眾健康,致令香港吸煙率一直下降至10%,是眾多發展地區中最低。

但就近期社會熱烈討論政府有意推出最新的控煙政策打擊電子煙、加熱煙及另類煙草產品流入香港一事,社會上有聲音質疑政策有雙重標準,只禁電子煙不禁傳統煙,以此藉口大力反對條例修改,甚至要求應先禁傳統煙再禁另類煙草產品。本會認為這樣捆綁式的討論對社會根本沒有益處,反觀他們漢視下一代的健康,將市民健康當作政治籌碼,我們擔心萬一法例未能獲得通過,香港最終要為這場政治角力付上沉重的代價。

傳統煙已在香港有過百年歷史,不適宜亦不能現階段以一刀切的方法去處理傳統香煙,唯有採用多管齊下的控煙措施,並嚴格實行以減低吸煙率,事實亦見成效,但需要耗用數十年的時間及努力不懈才有今日的成果面對電子煙、加熱煙等不同形式的煙草產品於全球的風行,立法過止是具有過切性的需要,防止香港吸煙率有任何大幅反升機會的可能性,導致香港的控煙工作前功盡廢。當然,我們認同「禁止傳統煙」絕對有討論的空間,但要循序漸進,而不是捆綁式的做法。而我們亦相信政府會繼續加強政策,令傳統煙的使用進一步減低至可以實施全面禁煙。

希望各位立法會議員明白一點,我們亦沒有必要浪費時間去衡量傳統煙以及其他煙草產品的利與弊。因為所有的煙草產品均有損健康,吸煙危害健康,是鐵一般的事實。同時,世界衞生組織指出從未吸煙的成年人使用電子煙,會使其開始吸煙的可能性增加至少一倍。為守護市民健康,政府及尊貴的議員絕對責無旁貸,盡快落實全面禁止電子煙、加熱煙等另類吸煙產品。

我們的立場與政府控煙政策的目標一致,由久而來都非常堅定、明確,就是冀 盼終有一日能夠達至無煙香港。如果可以重新開始回到最初煙草尚未流行的時 候,我們鐵定不移誓會提倡全禁傳統煙,令煙禍絕跡。所以懇請大家以此為 鑑,絕對不可以讓歷史重演,放生另類吸煙產品,讓他們於香港落地生根。

近年,全球電子煙、加熱煙等不同形式新煙草產品的興起引起社會大眾的關注。本會亦於社區內聽取不少市民意見,大家反映對於今次政府能夠適時推出這項禁煙措施表示十分贊同,認為只有立法才能夠保障減低青少年免受煙草誘惑的機會。不少街坊起初誤以為電子煙及加熱煙的並非吸煙的一種,反而誤以為是流行玩意,而且形狀和味道亦與一般煙仔不一樣,所以不容易察覺。即因此容易本會認為此例一旦未能獲得立法會通過修改,必會嚴重影響市民的生活及健康。

根據資料,電子煙的銷售手法巧立名目,雖然煙草商以幫助戒煙或聲稱煙害較傳統香煙少為名,但實則推出的過萬種口味及強調「不會上癮」的宣傳手法,目的是催谷一班好奇心重的年輕人購買電子煙的意慾,其針對的顧客市場顯而易見,絕非傳統煙民,而是從不吸煙的人士、青少年更甚至兒童。煙草商曾於全球的熱門網上平台上舉辦電子煙煙霧特技大賽,藉此美化吸煙的行為,令年輕人誤以為吸食電子煙有吞雲吐霧之快感,情況更令人擔憂的是這項吐煙的行為已於外國被捧為追求時尚的玩意。

早已有報章報導,香港竟然有六、七歲的兒童在公園內結隊成群地使用電子煙。在沒有宣傳下竟風行如此,我們相信即使日後只是禁止 18 歲以下人士使用,亦難以杜絕在青少年間興起。再者,如同傳統煙仔一樣,無論是青少年還是成年人亦沒必要使用這些電子煙和加熱煙。

坊間流行的電子煙及加熱煙等另類煙草產品以「更少危害」、「健康環保」等掩蓋其潛在安全及健康風險,災難醫療學會對此強調電子煙等煙草電子產品存在對人體構成安全和健康的風險,市民應多加注意,而政府更應及早通過立法全面禁止另類煙草產品,以保障廣大市民得享健康與安全的生活。

電子煙及加熱煙等是煙草產品的一種,它們所含有的尼古丁、焦油成份與傳統煙相若。煙草的危害無容置疑,無論是一手煙、二手煙或者三手煙,都會威脅到我們每一個人的健康。公共衞生學者特別提醒使用電子煙的市民需要慎防煙彈產生的不明物質吸入肺部,嚴重影響健康。當大家著眼於另類煙草產品的有毒物質時,往往忽略了它們也能夠帶來的潛在安全危險。

電子煙草產品的安全性一向備受關注。去年,在美國佛羅里達州一名男子在吸 食電子煙期間,主機機身突然爆炸而死亡。事件引起大眾關注電子煙機身設計 及內置電池供電的安全性。

《兒科期刊》刊登的一份醫學研究指出,電子煙造成大量 6 歲以下兒童中毒案例,主要與誤服電子煙中的尼古丁溶液有關。電子煙的煙油多次被驗出含有有毒物質,包括尼古丁、焦油、甲醛等。兒童接觸到煙油會引起不同程度的反應及傷害,輕則有呼吸困難、心跳加快等,重則可引致死亡。根據美國毒物控制協會表示,一茶匙的尼古丁液體足以令兒童致命。早已有不少媒體曾報導過嬰兒因接觸到有毒電子煙液而死亡的案例,例如一名 2 歲的以色列女孩在祖父的煙油藥瓶中接觸到少量尼古丁後死亡。不幸的,這不是第一宗案例,而是冰山一角,有更多的未能於是次公聽會上逐一為大家分享,但這些無辜的兒童慘案已經讓人觸目驚心。

於 2012 年 1 月至 2015 年 4 月期間,「全美中霉數據系統」接獲了 29,141 宗兒童因為尼古丁或煙草中霉的個案,電子煙造成兒童中霉的案件有 4,128 宗,三年間增加了近十五倍,幅度驚人。從這些數據得出的結果令人不得不思索電子煙的安全性和對健康的影響。為維護公共健康,本會懇請盡快通過有關電子煙及另類吸煙產品的進口、製造、售賣、分發和宣傳的法例修改,以避免類似的安全意外在香港發生。

Re: Amendment Bill to ban the import, manufacture, sale, distribution and advertisement of alternative tobacco products which include e-cigarette, heated tobacco products and herbal cigarettes

Dear Hong Kong Legislative Council,

I am writing to express my concern regarding the Hong Kong Govenrment's Amendment Bill that proposes to ban the import, manufacture, sale, distribution and advertisement of alternative tobacco products which include e-cigarette, heated tobacco products and herbal cigarettes. I view that the amendment bill does not reflect accurately the concept and strategies of tobacco harm reduction on alternative tobacco products that encourage smokers to switch to less harmful products. Any public health policies that is not grounded in science is wrong and unethical.

The harm reduction concept involves strategies on how to find suitable substitutes for a high-risk product or behavior for a lower risk product or behavior. Many consumer products or behaviors are known to pose health risks such as tobacco use, harmful use of alcohol, unhealthy diet, and physical inactivity. I truly believe that harm reduction is a must have concept to be introduced and fully supported to sustain Hong Kong tobacco control along with other equally essential measures such as education on product content, and dangers of its use or excessive use.

Hong Kong is ratifying member of FCTC, it provides an important key messaging on tobacco harm reduction as article 1 of FCTC explain "tobacco control means a range of supply, demand and harm reduction strategies that aim to improve the health of a population by eliminating or reducing their consumption of tobacco products and exposure to tobacco smoke;" as a consequence of that provision, there is an obligation on FCTC parties to not only allow reduced risk tobacco alternative products, but to actively promote them as part of implementing their tobacco control policies.

Measures taken by the policy makers shall be based on the most current and relevant scientific, technical and economic considerations. A recent study by Georgetown University Medical Center published in the Journal of Tobacco Control reveals that if smokers are to switch to alternative tobacco products, the potential lives that could be saved are as much as six million people.

Hence, these alternative tobacco products can be regulated in a way that encourages current adult smokers to stop smoking at all, and if not possible, switch to a new novel product that potentially poses less harmful consequence while at the same time minimizing undesired use by non-smokers and minors through appropriate Government oversight to safeguard and strengthen public health interest.

I strongly recommend a proper public consultation and regulatory impact assessment should be conducted by the Hong Kong Government before this legislation is amended in order to uphold science's role and scientific integrity in public health policy-making.

本人是民選區議員、服務於流動人口最多的灣仔區。每天透過走到街上接觸不同的市民,對市民 在各方面的需要和期望都會關注,尤其在保障公眾健康、關心青少年成長方面。就政府修訂《吸 煙(公眾衞生)條例》,禁止進口、製造、售賣、分發和宣傳電子煙及其他新型吸煙產品,本人表示 支持是項法案、懇請立法會盡快通過、並要求政府加大力度推展控煙及相關工作。

眾所周知,吸煙不單是個人行為,而事實上,每一口煙均會影響周邊人的身體和健康。而吸煙的 行為,已不限於吸食傳統煙,也包括在外國廣受歡迎的電子煙和加熱煙。為了追上潮流,尋求刺 激和讓自己變得"型格",不少青少年都對電子煙和加熱煙趨之若驚。最值得我們關注的是,吸 食這類煙品在本港是沒有相應法例規管的,大小朋友都可以輕易買到形形色色、聲稱不含尼古丁 的電子煙產品。以本人平日在社區中觀察,區內有很多出售年輕人潮流玩意、手機或電腦等產品 的商場和店舗,當中亦有部份銷售另類吸煙產品,致使區內青少年和兒童無可避免地接觸到這些 產品。據一些傳媒報導,一些幾歲大的小朋友已將吸食電子煙當成習慣,皆因有不少電子煙品是 加了朱古力或水果味,吸引到小朋友嘗試新口味新玩意實在是輕而易舉。小朋友在成長期當中吸 食電子煙或加熱煙,越食越過癮,最終在長大後變成傳統卷煙煙民,相信是大勢所趨。

# 灣仔中西區工商業聯合 促請政府立法全禁另類煙草產品

灣仔中西區工商業聯合會於 2009 年成立,本會以「敦親睦鄰,和諧社會,共創未來」為目的,聯繫和團結灣仔、中區及西區各工商業界友好,創建穩健營商平台,進而拓展本港及內地商貿投資活動。

本會設立多個委員會,包括:青年事務委員會、女企業家委員會、醫 務委員會、地產及建築委員會、法律事務委員會以及創新資訊科技委員 會,目的希望結集各界專業人士,於不同範疇吸納人才,拓展網絡。

現就政府提出立法全禁另類煙草產品,有以下意見:

現已有研究指出傳統捲煙含有超過7,000種的有毒化學及致癌物質, 隨著全球控煙趨勢及消費者對健康的重視,香港吸煙率持續下降,傳統 捲煙市場日漸萎縮,煙草業亦應步入「夕陽行業」之列。

多年來,煙草業為了賺取可觀的利潤,不斷以新瓶舊酒方式為煙草重新包裝後重投市場。回望六、七十年代,煙草商透過大眾傳媒將吸煙行為打造成型格及身份象徵,令吸煙風氣盛行;再而將捲煙「瘦身」,加上粉色亮麗的煙包,開拓女性市場,將吸煙與女性自由解放、獨立權力拉上等號。及後,煙草商更於包裝上加入「淡味」、「低焦油」、「特醇」等字眼、於燈箱高調陳列展示產品等其他推銷策略,企圖淡化煙害,力保行業生存空間,罔顧公共衞生及市民健康。

近年,煙草商為了增大煙草的市場佔有率,再次使用類似手段,意圖利用加入電子科技,將尼古丁換個形態,研發出外型新奇多變的電子煙及加熱煙,其實又是把煙草產品重新包裝的一個市場策略。煙草業真的「無所不用其極」,將各式各樣口味的電子煙等另類吸煙產品設計成潮流玩物推出市面,標謗不會上瘾、較健康、有認証等用詞作宣傳伎俩,吸納青少年、一眾非吸煙者踏入煙草消費群,成為尼古丁長期上應依賴者,為煙草商注入可持續發展的本錢。

根據香港大學的研究指出,雖然吸煙率有所下降,但吸煙仍對香港的經濟和公共衞生造成負面影響,導致香港6,826人死亡及港幣56億元經濟損失。香港政府多年來都推出不同的控煙政策,更已經訂立於2025年前降低吸煙率至7.8%的目標。前車可鑑,煙草業一而再、再而三將尼古丁變種入侵香港市場,本會促請政府在電子煙以及另類煙草產品佔據整

個市場前,盡快通過立法全面禁止,防患於未然,保障香港長遠的經濟 和公共衞生發展。

#### Submission to Legislative Council Deputation on Total Ban of Alternative Smoking Products

The Hong Kong College of Paediatricians with a commitment to the health of children unreservedly supports the Smoking (Public Health) (Amendment) Bill 2019 to safeguard the health of the public, especially our next generations. Our College appreciates the government initiative to prohibit the import, manufacture, sale, distribution and advertisement of alternative smoking products, including e-cigarettes and heat-not-burn tobacco.

With regard to the Smoking (Public Health) Amendment Bill 2019, our College has the following comments:

#### Misleading advertising targeted at youth

Our College worries that the marketing strategies of e-cigarettes are mainly targeting at young people. E-cigarettes are advocated as healthy and trendy products through various online social media to induce teenagers to try. Most e-cigarettes are marketed as non-addictive, safe and harmless which mislead youngsters-about their safety and attract them to use.

Safety in doubt, containing harmful substances that cause health risks
Our College is concerned that e-cigarettes contain toxic substances that are
detrimental to health. Overseas researches found e-cigarettes contain
chemicals that are harmful to health e.g. nicotine, propylene glycol,
formaldehyde, tobacco-specific nitrosamines and heavy metals that may lead
to addiction, respiratory diseases and even cancer and death. Study by Hong
Kong Baptist University on e-cigarettes sold in Hong Kong also found related
harmful chemicals.

#### Gateway to youth smoking

Our College agrees that e-cigarettes open the gateway to the eventual consumption of conventional cigarettes by youngsters. The Secondary School Smoking Survey 2012/13 conducted by the School of Public Health of the University of Hong Kong found that e-cigarette users were more likely to smoke cigarettes in years to come. To nip in the bud and safeguard the health of youngsters, total ban of alternative smoking products should be implemented to prevent e-cigarettes becoming an affordable gadget of smoking.

#### Conclusions

The Hong Kong College of Paediatricians strongly supports the government and Legislative Council to enact the legislation as soon as possible in order to prevent the public, especially the youth, from picking up e-cigarette use and the smoking habit. More and more scientific evidence demonstrates that e-cigarette use is harmful and would be a gateway to youth smoking. E-cigarettes will undermine Hong Kong's achievement in tobacco control over the past years. Our College has been and will be collaborating with other stakeholders in protecting the public from tobacco hazards and achieving a smoke-free Hong Kong.


# The truth behind tobacco firm's HK\$78m sham laboratory




Tobacco giant Philip Morris International (PMI) claims it may have to <u>close its HK\$78 million</u> <u>"research and development centre" (https://www.scmp.com/news/hong-kong/health-environment/article/3007030/tobacco-giant-philip-morris-warns-it-may-close)</u> in Wong Chuk Hang, with a loss of 60 local jobs, if the Hong Kong government goes ahead with its proposed e-cigarette ban.

But a visit to the facility shows the main function of the office is supply-chain work for PMI's Zhuhai iQOS factory, together with a lobbying showcase for the firm's "reduced risk" tobacco products. And not much more.

Blue Skies China took an exclusive tour of the facility in March 2019, eight months after its opening, guided by general manager of the Hong Kong and Macau branch of Philip Morris Asia, Brett Cooper.

At an estimated 20,000sq ft (around two thirds of the 13th floor of One Island South in Wong Chuk Hang), the office comprises secure reception, exhibition area, boardroom, pantry, large open-plan office, meeting rooms and a laboratory.

The boardroom is top-class, featuring leather sofas, library shelving (empty), an 18-seat boardroom table and the usual full suite of AV/electronic equipment.

The adjacent exhibition area, estimated at around 1,500sq ft, comprises a 3-D/hologram display of the iQOS proposition, comparing its emissions to traditional cigarettes; wall-posters of "lung disease" and "pulmonary disease"; display cabinets featuring PMI's latest products: iQOS; TEEPS (a heat-not-burn device lit with a traditional cigarette lighter); and VEEV (also called MESH in the UK), a traditional vaping pen.

The open-plan working area is enormous and has capacity for around 70-80 people – around five banks of 14 desks each. The office divided into "science" and "supply chain"; although the only staff seen were in the supply chain section (and only around 20 people visible altogether). The open-plan office is surrounded by around eight small glass-walled meeting rooms, each with capacity for 4-6 people.

And then there's the "laboratory", a 150sq ft room (estimated) behind a security door at the back of the office. The laboratory features two benches, some fabrication gear (unused, not entirely out of the packaging), weight scales and, the largest equipment on the bench, a Pantone colour matching light-box.

Such light-boxes are commonly used in supply-chain work: for example, to colour-match factory samples and retail products to original design specifications. A Pantone light-box could conceivably be used to examine and grade, for example, cigarette filter colouration; however the laboratory is not set up for burning, smoking or vaporising anything, as there's no directable exhaust system or fume cupboard, and any fumes or vapours from testing could easily contaminate other samples and pose a hazard to personnel. PMI has repeatedly been <a href="mailto:criticised for the quality of its laboratory work in the past (https://www.reuters.com/investigates/special-report/tobacco-iqos-science/">criticised for the quality of its laboratory work in the past (https://www.reuters.com/investigates/special-report/tobacco-iqos-science/</a>), but such an obvious blunder is unlikely: instead, it's more plausible the light-box is used (if at all, it wasn't plugged in) for simply examining iQOS packaging and devices for colour-matching and quality control. In other words, the humdrum supply-chain functions of offices all over Hong Kong.

In a glass-doored enclosure in the corner of the laboratory, hundreds of small batteries are racked up and are being tested for charging capacity and temperature.

But aside from the battery testing corner, the laboratory is pristine: not in a "clean room" way, but in a "never been used" way. Equipment still in packaging, eight months after the centre opened, is the biggest give-away that no science is going on here. An iQOS device, disassembled to expose its circuit board, appears left on the bench as a prop.

# Relocation looms: no loss to Hong Kong

Cooper says the centre will likely be relocated to Shenzhen if the Hong Kong e-cigarette ban is passed. But PMI's complaints about Hong Kong's lack of "innovation" or that it will be forced to close its "research and development" centre are disingenuous attempts to play the victim: there's no obvious research or development in the centre other than supply-chain work for products which have not yet proven their safety to the satisfaction of the US FDA

(https://www.ft.com/content/d26927da-57a7-11e9-a3db-1fe89bedc16e), let alone the Hong Kong government.

If PMI is genuine about reducing cigarette smoking, it should promote (rather than actively hinder, as it has done over the last few decades) basic successful smoking policies such as cigarette tax, age 21 limits and a point-of-sale cigarette packaging bans.

From a public health perspective, e-cigarettes and "reduced risk" technology may hold future promise in helping smokers to quit cigarettes: without calling such products safe, certain emissions are lower, and the technology will improve over time.

But witnessing PMI's propaganda machine in action, it's hard to see how firms such as PMI would wield these benefits to actually help people rather than to profit by aggressively expanding their customer base into new market segments (youngsters, for example). A firm which spends HK\$78 million on a sham R&D centre is one to be watched very closely indeed, and certainly shouldn't be trusted when it comes to discussing public health policy in the city.

#### Dear Bills Committee,

I am a researcher with the Washington State Department of Health. The views expressed below are my own and not the department's.

In 2016 the Washington State Legislature passed legislation regarding ecigarettes (vaping, etc.) and the law was greatly influenced and partly written by the tobacco industry. The law allowed vaping products to be sold through the mail, permitted vaping flavorings that appeal to children, disallowed preemption so that local jurisdictions could not pass more restrictive vaping laws, and the like.

Recently, the results of the Washington State Healthy Youth Survey for 2018 have been released. The survey shows that since the 2016 vaping law was passed, e-cigarette use by children in state has increased at an alarming rate. 30-day use trends indicate that vapor products use among 10<sup>th</sup> graders increased from 13% in 2016 to 21% in 2018. Among 12<sup>th</sup> graders during this same period vapor product use increased from 20% to 30%.

Washington State was achieving steady declines in smoking until the arrival of ecigarettes in the state. I strongly urge the Hong Kong government not to follow the example of my state, and be proactive against vapor products. LegCo in its wisdom should pass legislation against the sale and use of vapor products within the special administrative region.

I have attached Healthy Youth Survey information sheets regarding tobacco and vapor product use among children in Washington State for your use.







# Current (past 30-day) vapor product use compared to the state, all grades




# Reported substance "vaped" among current (30-day) vapor product users, Grade 12









# Current (past 30-day) vapor product use compared to the state, all grades




# Reported substance "vaped" among current (30-day) vapor product users, Grade 10



### 公民黨就《2019年吸煙(公眾衞生)(修訂)條例草案》意見書

政府在 2015 年已提出全面禁售電子煙及加熱煙等新興煙草產品,但過去數年立法工作不但紋風不動,更曾傳出政府向煙商屈服,建議讓加熱煙等合法化,實在令關注控煙問題的市民非常失望。直至今年 2 月,政府終於向立法會提交《2019 年吸煙(公眾衞生)(修訂)條例草案》文件,修訂條例以全面禁止電子煙及加熱煙入口、製造及銷售,違例者最高可罰款 5 萬元及判監 6 個月。

公民黨歡迎政府是次的修例,全面禁售電子煙將有效降低市民,特別是青少年接觸電子煙的機會,從而減低青少年透過接觸電子煙,轉為吸食傳統香煙的機會。

香港自 2003 年成為「世衞組織煙草控制框架公約」的締約方後,一直積極地進行控煙工作。由食肆全面禁煙做起,陸續擴展到室內公共場所全面禁煙、到增加特定室外禁煙區等等,一直以來控煙工作都是值得嘉許的。而是次的修例將令本港的控煙工作更進一步。

事實上,世界上不同的煙草公司已磨刀霍霍,正準備擴大電子煙的市場。若政府再遲遲不在本地修例,電子煙將攻陷香港的香煙市場。如擁有萬寶路等品牌的煙草巨頭公司 Philip Morris International 旗下電子煙 「iQOS」;擁有 Lucky Strike、 KENT 等品牌的 British American Tobacco 亦推出了「GLO」。兩間煙草巨頭,都銳意推出電子煙以取代傳統香煙。而以上兩款加熱煙,已有不少「煙民」轉食,於本港街頭隨處可見。

是項修訂理應獲得市民普遍支持,根據公民黨於去年八月進行的一項問卷調查顯示,有七成受訪市民支持全面禁售加熱煙。

然而,公民黨對是次修例,仍有以下的擔憂,包括:

 未來管控工作將會透過「控煙酒辦」和海關進行。過去控煙辦的 人手只有 140 人,而在去年底為應付處理管控賣酒的工作,新增 了約 30 人,未來若要再顧及電子煙的工作,將對「控煙酒辦」 構成相當壓力。就此呼籲政府,必需確保「控煙酒辦」有足夠人 手,以讓法例得以有效執行;
