Regulating would be a better approach to teenagers' consumption of the new class of tobacco products, because through regulations, government and schools can implement suitable content of classes and activities to educate teens at school the right concept and attitude when it comes to this issue.

I strongly oppose the ban of alternative tobacco products, and truly stand by that regulation is the way out.


