




I do not agree with the ban on alternative tobacco products and I support regulation for it!



Hello Chairman Kwok and Bills Committee Members:


Make regulation. Not ban


Don't ban alternative tobacco products. The government should regulate it (just like what they do with traditional cigarettes and alcohol) and put things under control with laws and rules.




I disagree with the government's decision to pose a ban on other alternative tobacco products.


Right now, all I see is evidence that the new products are a better choice to smokers, and no evidence showing the introduction would encourage youth uptake.


I am deeply disappointed by the news that the government is going to ban alternative tobacco products, such as e-cigarettes, and heat not burn products.


I also respectfully ask the Chairman to allow this letter to be circulated with Members of the Bills Committee.

Some of my friends and peers have switched to new tobacco products, as a non-smoker, I think new tobacco products has less smell and the air quality has so much improved when they smoke near myself in gathering activities. With the ban, does it mean that they will need to revert to the traditional cigarette again? Why is the Government taking this away this option from us?

Smokers in Hong Kong should have the choice of using something less harmful for themselves and people around them. Why is the Government taking away a better tobacco alternative that is available? We should be given a choice – both for the smoker and the non-smoker.

I urge you to take a role to help implement a more balanced approach and to regulate, not ban, the alternative tobacco products in Hong Kong.

尊敬的郭主席和法案委員會成員：


監管才是處理新煙草產品的正確方向。
