

I have been told by my staffs and friends that Mr. Chairman Kwok would welcome further comments in the LegCo public hearing. Therefore we would submit our views below and request to meet with Secretary Chan respective Kowloon West Geographical Legco Members (Hon. Cheng Chung Tai, Hon. Andrew Wan, Hon. Alice Mak Mei-Kuen, Hon. Junius Ho Kwan-Yiu, Hon. Chu Hoi Dick) to discuss on it. Hope this letter could be circulated with the members of the Bills Committee.

The emergence of alternative tobacco has been noticeable in my industry, with our outdoor bars and seating area. Once smelly, dirty and un-enjoyable for non-smokers, we now see more balance. This leads me to ask, why is there a ban on a product which helps my business provide a cleaner and safer environment? And by safer I am specifically meaning that we are at less risk of having fire incidents and burnt furniture.

At my bar in Kowloon area in Tsim Sha Tsui, a strip of road full of restaurants and bars, many of us have come to realize that our own working conditions can be improved. What makes me concerned is that having consumers who don't want to smoke normal cigarettes will be now forced to adopt their old habits and make my working area full of ash and smells affecting others.

This seems a bit strange. As a governing body, I would have expected more public consideration from the government. It feels like they have thought that one simple decision could eliminate a discussion or a whole community. I don't support smoking, but those that choose to do so, should also have the right to choose the better way to use tobacco.

Unfortunately the Government did not seek any public opinion. I am simply requesting that we should regulate to avoid youth consumption, avoid travelers who come and force them to adopt cigarettes and ensure that Hong Kong smokers also have a choice. Why are we not hosting a public consultation for these consumers and businesses to share their thoughts? Should Hong Kong allow for a balanced discussion and come to terms for what would be best? I hope you can understand my views.

I understand as a LegCo member you have ability to support my views. I hope you can provide your

honest consideration on the topic. Your voice is crucial for the government to see us small businesses are also affected by their decisions, and that they should listen to us. As such, the Hong Kong Government should regulate not ban alternative tobacco products.

I also would like to request the Chairman to circulate this letter with the Members of the Bills Committee.

I am writing to request the Bills Committee to reconsider the recent proposal from the Government to pose a ban on e-cigarettes and alternative tobacco products. As a bar owner myself, I recognize the benefit of these products to both smokers and even non-smokers as they help making my premise a cleaner and safer place with less smell and even less risk of having fire accidents.

I have many concerns about the full ban which the government is proposing now rather than to regulate e-cigarettes and Heated Tobacco Products. If these products are properly regulated like how cigarettes are being regulated now, they would not be reachable by youth. There are also not much official documents letting us know how well or bad are these products compared to cigarettes. I hope the

government can let us know if there are authorities releasing research results from other countries that we can learn from.

Apart from that, I would like to request a consultation to share our views from all aspects of life and ask for the Government to provide feedback on our views directly.

As you are the LegCo member who has joined the Bills Committee for this Smoking Bill, we request that you would lend your hand in support for a balanced approach to protect the public health and the consumers' freedom of choice.

Based on the above, I urge the Government to regulate, not ban these alternative products in HK.

As a bar owner in Prince Edward district, I have noticed a growing trend of my customers and employees using new tobacco product during the past years, and not cigarettes anymore. I can see the potential positive impact of these products which can improve the lives of smokers and even non-smokers nearby. These alternative tobacco products apparently have less lingering smell that will not upset people around us.

I am a supporter of regulating these new tobacco products instead of a ban, and my concern about the current proposal is that the government did not disclose data comparing cigarette and these new tobacco products. There has not been a proper consultation to gather the public opinion neither. If something has to be regulated or banned, the public needs a holistic view with both positive and negative aspects to choose their stance.

I hope that as being one of the LegCo members representing the functional /geographic Constituency, you will help to support a neutral approach considering the wellbeing of the Hong Kong people and respect the consumers' freedom of choice.

I urge that Government should regulate these products in Hong Kong, not ban them. This is a solution that will address Youth Smoking concerns while providing a better alternative for Adult smokers in Hong Kong.

Being a non-smoker myself and so do some of my employees, this has greatly improved our working environment and even making it more inviting and enjoyable to the non-smoker customers.

I have many concerns about the proposal especially seeing it not consulted by the public, I also did not see the government releasing official documents regarding the comparison between these alternative tobacco product and cigarettes. Like what the Chairman of the Bills Committee

has stated during their meeting, a lot of smokers have already switched to these alternative tobacco products since the government has delayed the proposal. Should the government revisit the current situation of the society before even making up their mind?

It is clear the public has doubt if the Food & Health Bureau have considered views from the public or any interested parties. Besides, Hong Kong has a proven success on regulating of cigarette, which only adults can legally buy cigarettes. We kindly ask for a consultation and not just a public hearing to share our views and ask for the Government to provide feedback on our views directly.

As you are the LegCo member who has joined the Bills Committee, I hope to see Hong Kong evolve to give a better environment for its people to live and grow with your help. I also hope that you can speak to the government to conduct a proper consultation so everyone can get a more holistic picture of the issue. This can be achieved by regulating these tobacco products and not by the ban.

I am a supporter of these heat not burn products should be regulated rather than a ban, and my concern with the current proposal is that the government has not disclosed data on comparative cigarettes and these new tobacco products. There is no proper negotiation to collect public opinion. If certain things must be regulated or prohibited, the public needs to consider both positive and negative aspects in order to choose their own position.

It is clear the public has doubt if the Food & Health Bureau have considered views from the public or any interested parties. Besides, Hong Kong has a proven success on regulating of cigarette, which

only adults can legally buy cigarettes. We kindly ask for a consultation and not just a public hearing to share our views and ask for the Government to provide feedback on our views directly.

I strongly ask the Hong Kong Government to regulate, not ban heat not burn products in Hong Kong.

To add on, please regulate these e-cigarette and alternative tobacco products, as regulating will provide a choice for current smokers to choose a better alternative than smoking cigarettes. It also ensures the youth will not have access to tobacco products through illegal ways.

Since you are a LegCo member in the Bills Committee, please speak up to the government to conduct a public consultation for the public to express their opinions. I hope you will support a balanced approach to this issue.

I have been working in a bar for years now and I have almost been a smoker for some years. I have recently noticed that my customers and people who working with me have start to use of these "new tobacco products" instead of cigarettes in the past few years. I have also started to try out these products and the effects I am experiencing now is quite surprising. There are much less smell and smoke that will affect others, so will hardly disturb people around us, which I would say is a good news to my non-smokers customers since they enjoy a pleasant environment for a drink without worrying the second hand smoke.

I would like the Government to clarify some doubts I have in mind, if these new tobacco products are properly regulated by law, like how cigarettes are being regulated now, they

would not be reachable by youth, and the Government should also be able to arrest people who trade illegally. I also wish the Government would release official documents comparing these products and traditional cigarettes so smokers can choose their best-suit product with their own risks. Furthermore, on 30<sup>th</sup> Apr 2019, the US FDA announced that the IQOS is authorized for sale in the USA, and it is confirmed that IQOS is appropriate for the protection of public health. There is no way for LegCo to ignore this fact, please take a look at the public announcement by FDA in <a href="https://www.fda.gov/news-events/press-announcements/fda-permits-sale-iqos-tobacco-heating-system-through-premarket-tobacco-product-application-pathway">https://www.fda.gov/news-events/press-announcements/fda-permits-sale-iqos-tobacco-heating-system-through-premarket-tobacco-product-application-pathway</a>

As the Director of Goldpoly Company Ltd, a "Logistics Service Provider" company operating in tobacco industry in Hong Kong and other five Asia countries for more than 30 years, I would like to request the Bills Committee to have a have a proper public consultation for the regulation of alternative tobacco product instead of strictly banning it without a full consideration of opinions from all stakeholders.

We understand the proposed law not only forbids the any HK citizen from choosing a better alternatives of cigarettes products that produces less smell and harm inside Hong Kong territory. It may also disallow the importation of the alternative tobacco products and this will impose unnecessary constraints on our business environment and have a big negative impact on our business.

In addition, the ban contradicts the intention of the Hong Kong government to develop Hong Kong as the major logistics hub in Asia and Hong Kong will lose more of its competitiveness as a Regional Hub to our nearby countries.

It has come to my attention that in the LegCo public hearing, Chairman Kwok has mentioned that further comments on the subject are welcome. In response to this open invitation, I hereby respectfully submit my view on this matter and would like to ask to meet with the Secretary to discuss our views on the subject matter.

I also respectfully ask the Chairman to allow this letter to be circulated with Members of the Bills Committee.

As a professional in Hong Kong I believe we should have our regulatory framework based on principle and correct information in Hong Kong. I understand alternative heated tobacco can potentially reduce harmful chemicals than cigarette smoke, and this is supported by various studies in the US and UK conducted by independent parties.

The proposed ban in Hong Kong thereby in my view restrict the freedom of choice for 600,000 existing smokers to switch to an alternative tobacco products and I cannot understand the logic of such regulation.

From what I have learnt through different sources from around the world, I understand that these alternative tobacco products potentially reduce up to 95% harmful chemicals than traditional cigarettes.

The Food and Drug Administration (FDA) recently took an important action to improve the US nation's health by approving the heat-not-burn product – IQOS to be available for sale

in United States. (<a href="https://www.washingtonexaminer.com/opinion/fdas-best-health-move-this-year-approving-a-new-tobacco-product">https://www.washingtonexaminer.com/opinion/fdas-best-health-move-this-year-approving-a-new-tobacco-product</a>)

Public Health England ("PHE") has recently released a new film showing the devastating harms that come from smoking, and how this can be avoided by switching to e-cigarette, heated tobacco or another type of quit aid. Around 2.5 million adults are using e-cigarettes in UK, and they have helped thousands of people successfully quit (<a href="https://www.gov.uk/government/news/phe-health-harms-campaign-encourages-smokers-to-quit">https://www.gov.uk/government/news/phe-health-harms-campaign-encourages-smokers-to-quit</a>).

As a non-smoker, I fully agree that traditional cigarette is harmful. Alternative tobacco products would be another options for those who would like to continue to smoke and/or cannot quit due to their own personal reason. Total ban to these alternative products, not only leave smokers in Hong Kong no choice but to continue on traditional cigarettes, which is known to be more harmful. In addition, this would encourage illicit trade and the black market – but not helping in protecting those under-aged, which is the point HK government is focusing on.

I urge the Hong Kong Government to regulate, but not ban these alternative heated tobacco products in Hong Kong as I can only see benefit to the general public with these new alternative products.

Thank you for taking the time to read my letter and really hope you can help to pass this message to the Government and resulting the right action.

I work at a bar in tst. Week on week there are different consumers visiting the area and also choose to smoke. However some of my consumers currently have already switched to use these alternative tobacco products. This has benefitted my working environment and also my staff which some are non-smokers

This seems a bit strange. As a governing body, i would have expected more public consideration from the government. It feels like they have thought that one simple decision could eliminate a discussion or a whole community. I don't support smoking, but those that choose to do so, should also have the right to choose the better way to use tobacco.

We kindly ask for a consultation and not just a public hearing to share our views and ask for the government to provide feedback on our views directly.

As a business owner in the hospitality industry, i am on the forefront of both the tourism sector and also hope to see hong kong evolve to give a better environment for

its people to live and grow. As you have a position to represent the people i hope you can take the best action and support a balance approach for all parties in hong kong.

Since you are a legco member in the bills committee, please speak up to the government to conduct a public consultation for the public to express their opinions. I hope you will support a balanced approach to this issue.
