



致立法會衛生事務委員會，

各位議員、主席，議會的朋友，

認可醫療專業註冊先導計劃提交意見書

本人在2015年到美國紐約，接受臨床心理實習訓練，2016年畢業於城大同Alliant international University (AIU)合辦的臨床心理學博士學位課程，之後在紐約受聘為臨床心理學家，以limited permit 執業了若兩年。我現在在一所精神科醫生診所，私人執業，提供心理輔導及治療。

心理學會-臨床心理學組（學組）的方案寫明不接納私人執業經驗作為能力證明，只接受NGO/政府的執業經驗。我認為這樣是剝奪了受着精神困擾的人士的求診機會。我接觸的人士有以下幾類：

- 1) 他們正在輪候看政府精神科的人士，據我的病人透露，他們要等半年到一年，但他們是需要即時的治療；
- 2) 他們的精神困擾徵狀比較初期，未必需要服食精神科藥，但接受心理治療，會幫助他們找到適合應對困境的方法，可預防危機出現；
- 3) 他們是經濟環境較佳，願意付較高收費，以得到較快及時間可彈性安排的精神健康服務。

但是，現在CU及HKU畢業的私人執業臨床心理學家只有約10%，如果學組的建議書不接納私人執業經驗作為能力證明；這批有需要的人士就更難找到適切，時間又可彈性安排的精神健康服務，他們難免要付出更昂貴的診金，或讓病情漸漸惡化。**造成不少社會問題。**

對於我個人而言，我會失去執業機會，一旦不能獲得認證，也不會再有機構聘請；私人執業亦不會有病人上門，我當然承擔了很大的損失，對香港市民來說是浪費了可以幫助他們的寶貴人力資源。

現在很明顯協會與學組無法自行疏理分歧，政府應委託第三方認證專家制訂認證標準或評估方案，若界別仍然存有分歧，則應該暫緩落實計劃。


