(*Post-meeting note*: the Administration's reply to Assistant Legal Adviser's letter dated 4 December 2018 was circulated to members on 13 February 2019 vide LC Paper No. CB(1)396/18-19(01).)

2. <u>The Chairman</u> welcomed representatives of deputations and individuals to the meeting. He reminded them that their written submissions provided to the Bills Committee and views presented at the meeting would not be covered by the protection and immunity provided under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382).

Presentation of views by deputations/individuals

- 3. At the invitation of the Chairman, a total of 101 deputations/individuals presented their views at the meeting. The salient points and questions they raised on the contents of the Bill and enforcement of the proposed charging scheme for the disposal of municipal solid waste ("MSW") ("the proposed charging scheme") included the following:
 - (a) given that recyclables collected by some waste collection contractors of the Government were temporarily stored at refuse collection points ("RCPs") pending further transportation under the existing practice, whether the Administration would consider amending the proposed section 20M of the Waste Disposal Ordinance (Cap. 354) with reference to the proposed section 20P to the effect that a person who delivered to an RCP recyclables (including food waste) not wrapped in a designated bag ("DB") or attached with a designated label ("DL") would not commit an offence, and the said existing practice could then be maintained after the proposed charging scheme came into effect (if the Bill was passed);
 - (b) the Administration should clarify the policy intention in relation to the proposed section 20N of Cap. 354, which sought to prohibit the depositing of MSW that had a DL attached to it but that was not wrapped in a DB onto a "private waste vehicle" as defined under the Bill;

- (c) it appeared that there were loopholes in some provisions of the Bill, which seemed to be a mere adoption of the provisions in the waste charging legislation of Taipei city and Seoul. The practices adopted in other cities might not be suitable for Hong Kong;
- (d) there were concerns that the proposed charging scheme would cause undue burdens and legal risks to the frontline staff of the Food and Environmental Hygiene Department as well as other frontline cleaning staff who were not employed by the Government, as they would be required to reject non-compliant waste and might inadvertently commit an offence under the Bill when handling such waste;
- (e) given that routine "removal services" (i.e. services connected with MSW removal, as defined under the Bill) were generally performed within a short time frame (say about 20 minutes each day for a large housing estate), there would not be sufficient time for the employees of the property management company or the persons involved in the provision of removal services to inspect the waste collected from the premises and reject non-compliant waste before loading it onto the waste collection vehicle. Moreover, waste from different households was usually mixed in large refuse bins before it was loaded onto a waste collection vehicle, making it difficult to check whether all waste inside was wrapped in DBs;
- (f) the implementation of the proposed charging scheme might affect the existing voluntary activities related to recycling/reuse and waste removal, such as exchange of used goods and voluntary coastal clean-up activities, due to the legal and financial risks involved. For instance, coastal refuse collected during a voluntary clean-up activity might need to be wrapped in a DB before being delivered to a waste reception facility, or else the volunteer concerned might commit an offence under the Bill; and
- (g) it was unclear how the proposed MSW charge would be imposed on oversized waste.
- 4. <u>The Bills Committee</u> deliberated (index of proceedings attached at the **Annex**).

(The Chairman left the conference room at 3:26 pm and returned to the chair at 6:36 pm. During this period, the Deputy Chairman presided over the meeting.)
