## **Re: 9. Bills Committee on Professional Accountants (Amendment) Bill 2018**

### Our views and suggestions

It has been the concern of the Society on the existing of bogus CPA firms in Hong Kong as the business of our members who are practicing accountants are directly and adversely impacted. We keep raising this issue to both the Hong Kong Government and the HKICPA for many years but so far, the progress of cracking down on it is not to our satisfaction.

Although the proposed Amendment Bill is a bit late as the use of some of those proposed prohibited names has been used by companies in Hong Kong for long time (companies with the proposed prohibited names can be easily searched on Google), we welcome all the proposed changes in the Bill except for the amount of fine as further explained below.

Further, we strongly suggested that there should be a channel for the public to report suspected cases and to search for the names and details of the offenders.

### Proposed amount of fine

We are of the opinion that the present proposal of increasing the fine from level 4 to level 5 is still not an enough deterrent for potential offenders. As you probably know that certain sizable accounting companies now operating in the market bearing the words “註冊會計” 和 “專業會計” in their company names have been using overwhelming advertising campaign and having branches in prime locations to promote their businesses, the proposed HK\$50,000 fine (level 5) is definitely minimal as compared to their operating expenses and hence we would suggest the proposed fine to be HK\$300,000 (reference can be made to S379 of Companies Ordinance that

director failing to prepare company's financial statements can be fine for HK\$300,000 and also S433 that company and every responsible person failing to send copies of financial statements etc. to members before general meeting will be fine for HK\$300,000).

## Provide a channel to report suspected cases and to search the names and details of the offenders

We suggest HKICPA to add a webpage in their website similar to the "Scam Alert" webpage ([www.hklawsoc.org.hk/pub\\_e/scam/search.asp](http://www.hklawsoc.org.hk/pub_e/scam/search.asp)) of The Law Society of Hong Kong as a channel for the above purpose.
