A total of eight members agreed to discontinue the work of the Bills Committee and report to the House Committee the decision to discontinue its work, four members disagreed, and four members had not responded to the circular. As diverse views were received, the Chairman decided to convene this meeting. He invited members present at the meeting to express their views on the way forward of the Bills Committee.

- 2. <u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).
- 3. After discussion, the Chairman put the following motion to vote:

"The Bills Committee agrees to discontinue its scrutiny work on the Bill and report the decision to the House Committee."

4. <u>Members</u> voted by a show of hands. Seven members voted for and one member voted against the motion. No member abstained from voting. <u>The Chairman</u> concluded that the Bills Committee would discontinue its scrutiny work and report the decision to the House Committee the soonest possible.

001617 – 001729	Chairman Mr SHIU Ka-fai	Mr SHIU did not support convening additional meetings in haste for the sake of completing the scrutiny of the Bill. He supported discontinuing the work of the Bills Committee.			
001730 – 001840	Chairman Mr LAU Kwok-fan	Mr LAU did not consider it feasible to complete scrutiny of the Bill before the end of current legislative term and supported discontinuing the work of the Bills Committee.
