We shall aim at a smoke free Hong Kong and take away the dangers of smoking to young children and teenagers around the city. The recently introduced electronic cigarettes and other new smoking products, including Heat-Not-Burn (HNB) tobacco products, said to cause less harm to human beings have emerged in the market and have become popular among youngsters. However, the World Health Organization (WHO) have stated that even though the toxic substances produced by these new products are lower than those in the conventional cigarettes, they are unlikely to be harmless, and their long term use is expected to increase the risk of respiratory diseases, cardiovascular diseases, as well as some other diseases associated with smoking. In addition, the WHO considers that all forms of tobacco use, including the use of HNB products, are harmful and advises that HNB products should be subjected to the same regulatory measures as applied to all other tobacco products. We appeal to all Legislative Councillors to ban the import of cigarettes and tobacco products altogether into Hong Kong to save our people.

Furthermore, as alcohol is proven to be carcinogenic by the WHO, we would ask our Honorary members of the panel sincerely to consider ways to decrease the consumption of alcohol in Hong Kong and even to ban alcohol in the long run as it is proven to be a major worldwide cause of liver disease, particularly liver cancer.
