## I. Application for late membership

[LC Paper No. CB(2)1351/18-19(01)]

The Chairman referred to Mr AU Nok-hin's letter dated 30 April 2019 regarding his late application for membership of the Bills Committee. The Chairman said that since Mr AU's late application for membership was not made on the ground that the Member concerned was indisposed or away from Hong Kong during the time when membership for the Bills Committee was invited, it would be for the Bills Committee to decide whether there were sufficient grounds to accept the application.

2. Given the diverse views expressed by members, the Chairman put to vote the question as to whether the Bills Committee should accept Mr AU's late application for membership. The voting result was that one member voted for and five members voted against the question, and no member abstained from voting. The Chairman declared that the question was negatived.

# II. Meeting with deputations and the Administration [File Ref: CMAB C1/30/5/4, LC Paper Nos. CB(3)427/18-19, LS57/18-19]

- 3. <u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).
- 4. <u>The Bills Committee</u> received views from nine deputations/individuals on the Electoral Legislation (Miscellaneous Amendments) Bill 2019 ("the Bill"). The major views expressed by the deputations/individuals are summarized as follows:
  - some deputations urged the Administration to initiate an overhaul (a) of the functional constituency ("FC") system to broaden the electorate and review the composition of certain FCs, in order to raise the representativeness of these FCs. A deputation suggested that the electorate of the Sports, Performing Arts, Culture and Publication ("SPCP") FC should be broadened to include individual arts workers who had been specified by the Chief Executive ("CE") by notice in the Gazette for the purpose of nominating respective arts interest representatives for appointment to the Hong Kong Arts Development Council under the Hong Kong Arts Development Council Ordinance (Cap. 472). Another deputation (the Hong Kong Printers Association) requested that it should be included in SPCP FC so that the printing sector could be represented. other deputations expressed the view that representatives of organic farmers and students should be included as electors in the Agriculture and Fisheries ("A&F") FC and Education FC The Administration was requested to set out clearly its criteria for determining which corporates could be included as electors of FCs and the procedure for making such applications;
  - (b) some deputations, however, considered that the current composition of A&F FC was appropriate. Nevertheless, the Administration should also keep up with the new developments in the A&F sectors through consulting stakeholders, and consider including bodies representing newly emerged trades in the FC concerned so as to ensure representativeness and balanced participation; and
  - (c) some deputations expressed support for the proposals of extending the deadline for submitting election returns for CE elections from 30 days to 60 days. Diverse views were expressed on the proposal of raising the limits prescribed for ratifying minor errors or omissions in election returns under the de minimis arrangement

provided in section 37A of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) ("ECICO"). There was also a view that the Administration should step up its monitoring efforts to ensure that the de minimis arrangement was properly implemented, and duly follow up on cases where the cumulative amounts of errors or omissions exceeded the prescribed limits.

- 5. In response to the deputations' views, the Administration made the following points:
  - (a) following the established practice, before each Legislative Council general election, the Administration would conduct a review on the delineation of the electorate of FCs in consultation with relevant bureaux/departments. The review was conducted on the basis of the existing electorate and all relevant requests received from individual bodies/persons since the last review in 2015;
  - (b) the proposal to revise the threshold under section 37(2)(b) of ECICO for the submission of invoices and receipts from \$100 to \$500 aimed to help alleviate the workload of candidates when preparing their election returns; and
  - (c) with regard to the proposal to raise the limits prescribed for rectifying minor errors or omissions in election returns under the de minimis arrangement provided in section 37A of ECICO, the Administration said that the proposed limits prescribed for various elections were broadly proportionate to the respective election expense limits.

### Follow-up action required of the Administration

6. <u>The Administration</u> was requested to provide supplementary information on the number of invoices and receipts received by the Administration in relation to past CE elections.

7. <u>Members</u> noted that the Administration would propose a technical amendment to the long title of the Bill in response to the comment made by the Legal Adviser to the Bills Committee. <u>The Administration</u> undertook to provide its draft amendment to the Bill for the Bills Committee's consideration in due course.

8. <u>The Chairman</u> requested members who intended to propose amendments to the Bill to forward them to the Clerk on or before 15 May 2019 for onward transmission to the Administration for written response. <u>The Chairman</u> said that subject to any draft amendments proposed by members by the deadline, he would decide whether a further meeting was necessary.

She considered that the Registration and Electoral Office should hire lawyers to settle cases concerning minor inadvertent errors and ensure that only cases of a more serious nature would be referred to ICAC. The Administration undertook to consider Dr LEUNG's suggestion.	
005449 - 010519	Chairman Dr Helena WONG Mr AU Nok-hin Administration	Dr Helena WONG said that the Democratic Party was concerned whether the lack of progress in achieving the ultimate aim of electing all Members of the Legislative Council ("LegCo") by universal suffrage was in contravention with the "principle of gradual and orderly progress" in Article 68 of the Basic Law ("BL 68"). She and Mr AU Nok-hin took the view that even without amending the existing formation method for LegCo as prescribed in Annex II to the Basic Law to reduce the number of functional constituency ("FC") seats or abolish all FC seats altogether, the democratic element of the electoral method could be enhanced if the Administration took bolder steps to broaden the electorate of FCs (e.g. by replacing corporate electors with individual electors). They sought details of the Administration's criteria for determining which corporates could be added or deleted as electors of FCs.

TVIAI KCI		Mr AU Nok-hin further said that he was a candidate for the Wholesale and Retail ("W&R") FC in the 2016 LegCo General Election. He expressed his concern that while he was an eligible candidate in the election because he fulfilled the requirement of having a substantial connection with W&R sectors, he was not eligible to be registered as an elector of the FC concerned. Mr AU was also dissatisfied that the applications for inclusion in FCs from certain bodies (e.g. the Hong Kong Organic Association and the Hong Kong Electronics and Technologies Association) had not been successful.  The Administration reiterated the established practice regarding the review on delineation of the electorate of FCs as detailed in paragraph 3 of the LegCo Brief; and that for a corporate to be added to an FC, it should be a representative one and was active in supporting the development of the sector concerned. The Administration further advised that if major adjustments were made to broaden the electorate of FCs significantly, it would be controversial and substantial changes would be involved. This would require careful consideration. In the information technology ("IT") sector, for example, the Administration was working on establishing a common benchmark on eligibility of different IT professionals in Hong Kong for recognition as electors in IT FC. Moreover, according to BL 68, "the actual situation in the Hong Kong Special Administrative Region" had to be taken into account in achieving the ultimate aim of returning all Members of LegCo by universal suffrage.	required
010520 - 011539	Chairman Mr CHU Hoi-dick Dr Helena WONG Mr SHIU Ka-fai Administration	Mr CHU Hoi-dick enquired why the proposed inclusion of Hong Kong Veterinary Association Limited ("HKVAL") in the Agriculture and Fisheries ("A&F") FC was not part of the Administration's proposal for the earlier consultation with the Panel on Constitutional Affairs ("the Panel"), and questioned if it was appropriate to add HKVAL to A&F FC, as the veterinary profession only provided ancillary services to the A&F sectors. Mr CHU also considered that bodies such as the Kadoorie Farm and Botanic Garden, the Produce Green Foundation and the Hong Kong Organic Resource Centre should be considered for inclusion in A&F FC because of their close connections with the agricultural sector.

		The Administration explained that at the time of consultation with the Panel in January 2019, the Administration was still processing several recent requests for inclusion in FCs, including the one submitted by HKVAL. The proposed inclusion of HKVAL in A&F FC became part of the Bill following the completion of the relevant process, taking into account that the veterinary profession was closely associated with the A&F sectors and in the light of the recent developments of the profession (e.g. the establishment of a local veterinary college and the launch of Hong Kong Strategy and Action Plan on Antimicrobial Resistance (2017-2022)).	required
011540 - 012008	Chairman Mr MA Fung-kwok Administration	Mr MA Fung-kwok was concerned that HKPA had not been included in the Sports, Performing Arts, Culture and Publication ("SPCP") FC despite HKPA's repeated requests. He said that while HKPA all along did not consider that it belonged to the insurance sector, it had been registered as an elector of the Insurance FC until it ceased to be an association of underwriters approved by the Insurance Authority. Mr MA raised concern that HKPA was now no longer eligible to vote in any FC despite the fact that it represented a significant number of printing firms and was active in supporting the development of the cultural and creative industries. He enquired whether it was possible to include HKPA in Schedule 1B to the Legislative Council Ordinance (Cap. 542) (i.e., composition of SPCP FC).	
		The Administration explained that until 2016, HKPA had been an association of underwriters approved by the Insurance Authority, and therefore it used to be registered as an elector of the Insurance FC until 2017. The request of including HKPA in SPCP FC as an umbrella organization would involve a significant change to the electorate of SPCP FC.  Mr MA took the view that since HKPA was a member of the publication sector, its inclusion in SPCP FC would only be a technical amendment to the relevant electoral legislation. The Administration advised that if the relevant request involved a substantial increase in the number of electors in the publication sector, it would still lead to a significant change to the existing electorate of the FC concerned, while the Bill only sought to
