First Reading and Second Reading (debate to be adjourned)

Franchised Taxi Services Bill

: Secretary for Transport and

After the Bill was read the first time and ordered to be set down for Second Reading under RoP 53(3), the public officer moved the Second Reading of the Bill. The question on the Second Reading of the Bill was proposed and the debate was adjourned. The Bill was referred to the House Committee in accordance with RoP 54(4).

Second Reading (debate to resume) and consideration by committee of the whole Council

Appropriation Bill 2019

: Financial Secretary

The debate on the Second Reading of the Bill, which was moved on 27 February 2019, resumed. After the public officers had spoken, the question on the Second Reading of the Bill was put and agreed to (details of division in **Appendix 2**). The Bill was read the second time and committed to a committee of the whole Council.

The Council became committee of the whole Council and considered the Bill. In accordance with RoP 68, the committee first considered the Schedule to the Bill. The question that the sums for 33 heads with no amendment as set out in the Official Record of Proceedings stand part of the Schedule was proposed. The committee proceeded to the first session in which a joint debate on the 33 heads was held. After Members and a public officer had spoken, the question that the sums for the 33 heads stand part of the Schedule was put and agreed to (details of division in **Appendix 3**).

During the consideration of the Bill by committee of the whole Council, the meeting was suspended at 10:00 am on 9 May 2019 for holding the Chief Executive's Question and Answer Session. The meeting resumed at 12:04 pm on the same day.

The committee proceeded to the second session. The question that the sums for 51 heads with amendments as set out in the Official Record of Proceedings stand part of the Schedule was proposed. A joint debate on the 56 amendments to the 51 heads and the sums for such heads standing part of the Schedule was held. The amendments were proposed by 16 Members<sup>2</sup> seeking to reduce various sums for the 51 heads. Members spoke on the amendments.

# **Next meeting**

The Council resumed. The President declared that the next Council meeting would be held on 15 May 2019 at 11:00 am.

The Council was adjourned at 7:37 pm on 9 May 2019.
