**Council meeting of 12 June 2019**

**Amendment to Hon Dennis KWOK's motion on  
"No confidence in the Fifth Term Government  
of the Hong Kong Special Administrative Region"**

Further to LC Paper No. CB(3) 649/18-19 issued on 29 May 2019, Hon Claudia MO has given notice to move an amendment to Hon Dennis KWOK's motion. As directed by the President, Hon Claudia MO's amendment will be printed in the terms in which it was handed in.

2. The President will order a joint debate on the above motion and the amendment. I set out below the relevant proceedings in which the President will:

- (a) call upon the motion mover to speak and move the motion;
- (b) propose the question on the motion;
- (c) call upon the Member who wish to move an amendment to the motion to speak, but no amendment is to be moved at this stage;
- (d) call upon the public officer(s) to speak;
- (e) invite other Members to speak;
- (f) call upon the motion mover to speak on the amendment;

- (g) call upon the public officer(s) to speak again;
- (h) invite the amendment mover to move his/her amendment and forthwith propose and put to vote the question on the amendment; and
- (i) call upon the motion mover to reply, and then put to vote the question on the motion, or the motion as amended, as the case may be.

3. For Members' reference, the terms of the original motion and the marked-up version of the amendment are set out in the **Appendix**.

**Motion debate on  
“No confidence in the Fifth Term Government  
of the Hong Kong Special Administrative Region”**

**1. Hon Dennis KWOK’s original motion**

That this Council has no confidence in the Fifth Term Government of the Hong Kong Special Administrative Region.

**2. Motion as amended by Hon Claudia MO**

That *the Fifth Term Government of the Hong Kong Special Administrative Region* (*‘the Fifth Term SAR Government’*) *has failed to command public support for a number of policies and in particular, it has acted ineptly and indecisively in handling the Fugitive Offenders and Mutual Legal Assistance in Criminal Matters Legislation (Amendment) Bill 2019* (*‘the Bill’*), and even *bypassed the normal procedures of scrutinizing the Bill by the Bills Committee and demanded that the Second Reading debate on the Bill be resumed at a Legislative Council meeting; the Fifth Term SAR Government has administered Hong Kong with executive hegemony and incessantly damaged the rule of law and the relationship between the Executive and the Legislature of Hong Kong, resulting in its failure to govern Hong Kong effectively and uphold the civil rights and well-being of Hong Kong people; in this connection,* this Council has no confidence in the Fifth Term Government of the Hong Kong Special Administrative Region *SAR Government*.
