**Council meeting of 19 June 2019**

**Amendment to Hon Tommy CHEUNG's motion on  
"Formulating a new mechanism for importing non-locally trained doctors"**

Further to LC Paper No. CB(3) 663/18-19 issued on 5 June 2019, Dr Hon Helena WONG has given notice to move an amendment to Hon Tommy CHEUNG's motion. As directed by the President, Dr Hon Helena WONG's amendment will be printed in the terms in which it was handed in.

2. The President will order a joint debate on the above motion and the amendment. I set out below the relevant proceedings in which the President will:

- (a) call upon the motion mover to speak and move the motion;
- (b) propose the question on the motion;
- (c) call upon the Member who wish to move an amendment to the motion to speak, but no amendment is to be moved at this stage;
- (d) call upon the public officer(s) to speak;
- (e) invite other Members to speak;
- (f) call upon the motion mover to speak on the amendment;

- (g) call upon the public officer(s) to speak again;
- (h) invite the amendment mover to move his/her amendment and forthwith propose and put to vote the question on the amendment; and
- (i) call upon the motion mover to reply, and then put to vote the question on the motion, or the motion as amended, as the case may be.

3. For Members' reference, the terms of the original motion and the marked-up version of the amendment are set out in the **Appendix**.

**Motion debate on  
“Formulating a new mechanism for importing non-locally trained doctors”**

**1. Hon Tommy CHEUNG’s original motion**

That this Council urges the Government to expeditiously formulate a new mechanism for importing experienced and quality non-locally trained doctors, so as to alleviate the shortage of doctors in the public healthcare system and effectively respond to the demand for healthcare services arising from an ageing population in Hong Kong.

**2. Motion as amended by Dr Hon Helena WONG**

That *as the public have to wait for an extremely long time for accident and emergency services and new cases of specialist services*, this Council urges the Government to expeditiously formulate a new mechanism for importing experienced and quality non-locally trained *specialist* doctors *who are Hong Kong people*, so as to alleviate the shortage of doctors in the public healthcare system and effectively respond to the demand for healthcare services arising from an ageing population in Hong Kong.
