**Amendments to Hon Charles Peter MOK's motion on
"Reactivating constitutional reform to resolve social conflicts"**

Further to LC Paper No. CB(3) 721/18-19 issued on 20 June 2019, Hon Claudia MO and Hon CHEUNG Kwok-kwan have respectively given notice to move amendments to Hon Charles Peter MOK's motion. As directed by the President, the amendments will be printed in the terms in which they were handed in.

2. The President will order a joint debate on the above motion and the amendments. I set out below the relevant proceedings in which the President will:

- (a) call upon the motion mover to speak and move the motion;
- (b) propose the question on the motion;
- (c) call upon the Members who wish to move amendments to the motion to speak in the following order, but no amendment is to be moved at this stage:
 - (i) Hon Claudia MO; and
 - (ii) Hon CHEUNG Kwok-kwan;
- (d) call upon the public officer(s) to speak;
- (e) invite other Members to speak;

- (f) call upon the motion mover to speak on the amendments;
- (g) call upon the public officer(s) to speak again;
- (h) deal with the amendments in the order set out in paragraph (c) above, i.e. first invite the mover of the first amendment to move the amendment and forthwith propose and put to vote the question on the amendment, and thereafter proceed to deal with the remaining amendment; and
- (i) after all amendments have been dealt with, call upon the motion mover to reply, and then put to vote the question on the motion, or the motion as amended, as the case may be.

3. For Members' reference, the terms of the original motion and the marked-up version of the amendments are set out in the **Appendix**.

4. Members are reminded that Hon Charles Peter MOK's motion originally scheduled for the Council meeting of 3 July 2019 will be rescheduled to another meeting.

**Motion debate on
“Reactivating constitutional reform to resolve social conflicts”**

1. Hon Charles Peter MOK’s original motion

That this Council requests the Government to immediately launch consultation on constitutional reform to enable members of the public to elect the Chief Executive and all Legislative Council Members by universal suffrage on the premise of no screening, so as to resolve social conflicts.

2. Motion as amended by Hon Claudia MO

That *the Umbrella Movement in 2014 in which members of the public strove for genuine universal suffrage of ‘one person, one vote’ without screening and the two processions in June 2019 which saw the participation of over a million people demanding Chief Executive Carrie LAM to step down and withdraw the amendment to the Fugitive Offenders Ordinance both stemmed from the absence of universal suffrage for the election of the Chief Executive without screening in Hong Kong; given the urgent need for promotion of genuine universal suffrage*, this Council requests the Government to immediately launch consultation on constitutional reform to enable members of the public to elect the Chief Executive and all Legislative Council Members by universal suffrage on the premise of no screening, so as to resolve social conflicts.

3. Motion as amended by Hon CHEUNG Kwok-kwan

That *the deep-rooted conflicts existing in Hong Kong have yet to be addressed properly and the inadequacies in the work of the Government have even aggravated the social atmosphere and intensified social conflicts, making it difficult for the community to discuss controversial issues rationally; in this connection*, this Council requests the Government to ~~immediately launch~~ *expeditiously identify ways of mending the social laceration brought about by the inadequacies in its work, in order to restore peace in society and enable the community to re-focus on initiatives to resolve the deep-rooted social conflicts, and gradually build an atmosphere conducive to the initiation of rational discussions that facilitate the handling of the extremely controversial*

consultation on constitutional reform ~~to enable members of the public to elect the Chief Executive and all Legislative Council Members by universal suffrage on the premise of no screening~~, so as to resolve social conflicts *more comprehensively*.
