**Amendment to Hon Kenneth LEUNG's motion on
"Conducting a comprehensive inquiry into the allegation of the Police
using excessive force during a public assembly on 12 June 2019"**

Further to LC Paper No. CB(3) 722/18-19 issued on 20 June 2019, Hon CHAN Hak-kan has given notice to move an amendment to Hon Kenneth LEUNG's motion. As directed by the President, Hon CHAN Hak-kan's amendment will be printed in the terms in which it was handed in.

2. The President will order a joint debate on the above motion and the amendment. I set out below the relevant proceedings in which the President will:

- (a) call upon the motion mover to speak and move the motion;
- (b) propose the question on the motion;
- (c) call upon the Member who wish to move an amendment to the motion to speak, but no amendment is to be moved at this stage;
- (d) call upon the public officer(s) to speak;
- (e) invite other Members to speak;
- (f) call upon the motion mover to speak on the amendment;

- (g) call upon the public officer(s) to speak again;
- (h) invite the amendment mover to move his/her amendment and forthwith propose and put to vote the question on the amendment; and
- (i) call upon the motion mover to reply, and then put to vote the question on the motion, or the motion as amended, as the case may be.

3. For Members' reference, the terms of the original motion and the marked-up version of the amendment are set out in the **Appendix**.

4. Members are reminded that Hon Kenneth LEUNG's motion originally scheduled for the Council meeting of 3 July 2019 will be rescheduled to another meeting.

1. Hon Kenneth LEUNG’s original motion

That this Council urges the Government to set up immediately an independent investigation committee to conduct a comprehensive inquiry into the alleged use of excessive force by the Police against members of the public and the press during a public assembly in the areas around the Legislative Council Complex and Admiralty on 12 June 2019, and to take follow-up actions and put forward recommendations for improvements based on the findings of the inquiry.

2. Motion as amended by Hon CHAN Hak-kan

~~That this Council urges the Government to set up immediately an independent investigation committee to conduct a comprehensive inquiry into the alleged, *given that the Complaints Against Police Office (‘CAPO’) has received quite a number of complaints of alleged* use of excessive force by the Police against members of the public and the press during *when handling* a public assembly in the areas around the Legislative Council Complex and Admiralty on 12 June 2019, ~~and~~ *this Council urges CAPO to expeditiously conduct, in accordance with the established procedures, a comprehensive inquiry into the relevant complaints in a fair and impartial manner, requests the Independent Police Complaints Council to closely monitor and review CAPO’s handling and investigation of the relevant complaints, so as to restore the facts and do justice to various parties concerned, and urges the Government* to take follow-up actions and put forward recommendations for improvements based on the findings of the inquiry.~~
