Question:

Regarding the responsibilities mentioned in Programme (4), i.e. (a) handling the day-to-day administration of the Consular Corps; (b) maintaining close liaison with the Office of the Commissioner of the Ministry of Foreign Affairs of the People's Republic of China in the Hong Kong Special Administrative Region (HKSAR); and (c) liaising with and providing host government services to the Consular Corps in the HKSAR, would the Government provide information on:

- 1. the Protocol Division's manpower establishment and expenditure involved in the above work in 2018-19; and
- 2. the Protocol Division's manpower establishment and estimated expenditure involved in the above work for 2019-20?

Reply:

At present, there are 3 officers in the Protocol Division whose duties include, but not be limited to, the handling of issues related to the day-to-day administration of the Consular Corps and provision of host government services to the Consular Corps in the Hong Kong Special Administrative Region (HKSAR). Their work involves close liaison with the Office of the Commissioner of the Ministry of Foreign Affairs of the People's Republic of China in the HKSAR as well as the Consular Corps in the HKSAR. In 2019-20, the Protocol Division estimates that there will be an increase of 1 Chief Executive Officer and 1 Senior Executive Officer posts to enhance its manpower support for the relevant duties.

The expenditure in 2018-19 on the day-to-day administration of the Consular Corps and provision of host government services to the Consular Corps was about \$0.34 million whereas the estimated expenditure for 2019-20 is about \$0.95 million which is mainly for

liaising with the Consular Corps, including organising events in honour of the Consular Corps and printing of the telephone directory of the Consular Corps.

(3) Under the Subhead "hire of services and professional fees", the estimated provision for 2019-20 is \$214,675,000, which is \$57,474,000 higher than the revised estimate of \$157,201,000 for 2018-19. This is mainly due to the smaller than expected expenditure on such services as studies and consultancy in 2018-19. In addition, the expenditure of various sections under this Subhead for 2019-20 will be increased. Therefore the relevant estimates are higher than the revised estimates for 2018-19.

- 3. Whether such support covers the expenditures incurred by former CEs on publicity on the Internet/social media; and
- 4. The estimated expenditure for the Government to support each of the 3 former CEs in 2019-20?

Reply:

In November 2005, the Government submitted to the Finance Committee (FC) of the Legislative Council the proposal of providing former Chief Executives (CEs) with office accommodation and administrative support. The aim is to support former CEs in discharging promotional and protocol-related activities including receiving visiting dignitaries and delegations, giving local and overseas media interviews, attending public and social events, and taking part in speaking engagements. FC agreed to the proposal. The Government has been providing relevant support to all former CEs in accordance with the proposal agreed by FC.

The numbers of promotional/protocol-related activities attended by the 3 former CEs in the past 5 years are as follows:

In the past 5 years, the 3 former CEs attended over 2 000 promotional/protocol-related activities which included receiving visiting dignitaries and delegations, giving local and overseas media interviews, attending public and social events, and taking part in speaking engagements. Given the large number of promotional/protocol-related activities, we cannot detail each of them.

The Government provides the former CEs with office accommodation and administrative support. The administrative support includes scheduling and making arrangements for public and social appointments for the former CEs, handling correspondence and enquiries, receiving guests, transportation and other general administrative duties. We do not have a separate account of the expenditure on individual activities.

In the past 5 years and 2019-20, the breakdown of expenses/estimates on the support services provided to the 3 former CEs by the Government is as follows:
