We do not have information on the reasons for the withdrawal of applications by the applicants.

#### Ouestion:

- (a) Further to Reply Serial No. FHB(FE)023, the Agriculture, Fisheries and Conservation Department (AFCD) issued letters to animal welfare organisations inviting their views on sites that may be suitable for conducting the trial programme in November 2018. Which organisations have been consulted?
- (b) Concern groups on animals in new development areas have always been requesting the Government to implement the Trap-Neuter-Return programme in villages which will be developed in the future in order to reduce the number of affected animals. Will AFCD consider the request? If not, what are the reasons?

#### Reply:

- (a) In November 2018, the Agriculture, Fisheries and Conservation Department (AFCD) issued letters to the following 13 animal welfare organisations (AWOs), which are dog rehoming partners of AFCD, to invite views on suitable sites for conducting the Trap-Neuter-Return (TNR) programme for stray dogs:
  - (i) Animal Friends;
  - (ii) Cheung Chau Animal Care;
  - (iii) Hong Kong Dog Rescue;
  - (iv) Hong Kong Paws Guardian;
  - (v) Hong Kong Rescue Puppies;
  - (vi) Hong Kong Saving Cat and Dog Association;
  - (vii) Kirsten's Zoo;
  - (viii) Lamma Animal Welfare Centre;
  - (ix) Lifelong Animal Protection Charity;

- (x) Protection of Animals Lantau South (now known as "Team for Animals in Lantau South");
- (xi) Sai Kung Stray Friends;
- (xii) Society for Abandoned Animals; and
- (xiii) Society for the Prevention of Cruelty to Animals (Hong Kong).

Besides, the letter was also uploaded onto AFCD's thematic website (www.pets.gov.hk).

(b) AFCD will consider proposals from AWOs for conducting the TNR programme for stray dogs in any locations, including new development areas. Upon receipt of such a proposal, AFCD will assess if the proposed location is suitable for conducting such a programme, taking into consideration a range of factors, including population density, community facilities in the vicinity, and traffic condition. If a location is found suitable, AFCD will facilitate the liaison between the coordinating AWOs and the District Councils concerned as well as the local stakeholders in order to introduce the programme, with a view to enlisting their support, and seeking approval from the Legislative Council for the relevant legislative exemption.

#### **Question**:

- (a) Further to Reply Serial No. FHB(FE)021, what are the contents of the expenditure of the Agriculture, Fisheries and Conservation Department (AFCD) involved in preventing cruelty to animals, including the enforcement of the Prevention of Cruelty to Animals Ordinance (Cap. 169) (the Ordinance)?
- (b) Does the Ordinance cover community animals?
- (c) Currently, animals other than dogs are not required to be implanted microchips and the Government does not maintain a database in this respect. How does the Government ensure that owners of lost animals can be found? Also, how does AFCD prevent and deter pet owners from abandoning their animals?

#### Reply:

- (a) The expenditure of the Agriculture, Fisheries and Conservation Department (AFCD) on the prevention of cruelty to animals, including the enforcement of the Prevention of Cruelty to Animals Ordinance (Cap. 169) (the Ordinance) is mainly for conducting investigation of suspected animal cruelty cases, and instituting prosecution should there be sufficient evidence. In the event that acts of animal cruelty are noticed by AFCD during their inspections to other relevant licensed premises (e.g. licensed animal trading and breeding premises), AFCD would also take necessary follow-up actions. There is no separate breakdown of the expenditure involved in the above work.
- (b) The Ordinance applies to all animals, including stray animals.

(c) A pet owner who has lost his / her animal, irrespective of whether the animal is microchipped, may seek assistance from AFCD by filing a report on the lost animal with detailed information and descriptions of the animal. Upon receipt of such a report, AFCD staff will match the information / descriptions provided with animals caught or received by AFCD's Animal Management Centres and would inform the relevant pet owner accordingly.

Under Section 22 of the Rabies Ordinance (Cap. 421), a keeper of any animal who abandons that animal without reasonable excuse is liable to a maximum fine of \$10,000 and to imprisonment for 6 months. When there is a suspected case of abandonment of animal, AFCD staff will conduct investigation, including checking if the animal is microchipped and / or gathering other available evidence such as witness testimony, CCTV recording, etc. with a view to identifying the owner of the abandoned animal, and take follow up actions as appropriate. In addition, AFCD continues the efforts in public education and publicity to actively promote responsible pet ownership and proper care of animals.

- (a) In assessing the applications for subvention submitted by animal welfare organisations (AWOs), the Agriculture, Fisheries and Conservation Department (AFCD) will examine:
  - (i) the objective(s) and expected result(s) of the proposed projects;
  - (ii) cost-effectiveness of the projects; and
  - (iii) the reasonableness of the proposed expenditure.

Depending on the merits of individual applications, the approved amount may not be the same as that applied for. Similarly, the amount of funds released is subject to review by AFCD having regard to the actual expenditure incurred and, as such, may not be the same as the approved amount.

(b) The criteria for assessing the applications for subvention submitted by the Society for the Prevention of Cruelty to Animals (Hong Kong) (SPCA) are the same as those listed in (a) above. The enhanced programmes and activities of SPCA to be supported by the increased subvention in 2019-20 include the management and control of stray animals (mainly through desexing and re-homing of animals), the provision of

assistance to Government departments in the investigation and handling of suspected animal cruelty cases, as well as organising public education on animal welfare.

(a) The Agriculture, Fisheries and Conservation Department (AFCD) currently operates 4 Animal Management Centres (AMCs) in the New Territories North (NTN), the New Territories South (NTS), Kowloon (K) and Hong Kong Island (HK). The requested information of the 4 AMCs is tabulated below.

\*The holding capacity of kennels depends on a number of factors, including if the animals are from the same litter or pack, the health status and behaviour of each animal. Despite the fact that the utilisation rate of the animal keeping facilities is

constantly at a high level, normally only one animal is housed in each kennel for the sake of better disease control and animal welfare.

- (b) AFCD encourages the public to adopt animals. At present, AFCD partners with 17 animal welfare organisations (AWOs) in arranging adoption services. Animals with a good temperament and health condition will be transferred to our partnering AWOs for neutering (mainly dogs and cats) and adoption. Any member of the public interested in adopting animals may approach the relevant AWOs directly.
- (c) The number of animals transferred to AWOs for re-homing over the past 3 years is tabulated as follows:

- (1) The Government replied that "The Food and Environmental Hygiene Department does not keep a breakdown of the irregularities by type". However, in reply FHB(FE)142 regarding market stalls which are found not in operation or in an inactive state, the Government stated that "The Department issued 1 063 verbal warnings and 1 166 warning letters, and terminated 26 stall tenancy agreements in 2018. In addition, 339 tenants had voluntarily surrendered their stalls before we issued the final warning letter". In this regard, how much information about irregularities of stall operators does the Government have? Can the Government provide more detailed information by category?
- (2) Please set out the number of cases of irregularities of public market stalls, details of irregularities and follow-up actions taken in all the 18 districts in the territory in the past 3 years.

#### Reply:

(1) In the Direct Investigation Report on the Food and Environmental Hygiene Department's Regulation of Market Stalls issued by the Ombudsman in August 2018, the Ombudsman urged the Food and Environmental Hygiene Department (the Department) to formulate effective measures to curb the irregularities of inactive operation of stalls in public markets managed by the Department. In the light of such recommendation, the Department has stepped up inspections of market stalls especially to those found not in operation, or in an inactive state such as short business hours or being used for storage purpose, etc. since 2018 and has been taking stock of the action in tackling such irregularities. However, the Department does not keep a breakdown of other irregularities by type.

#### **Question:**

To follow up Reply Serial No. FHB(FE)126, please advise this Committee of the following:

- 1) Items e and f of the question seek information from the Department on the total amount of refuse collected in the districts served by the Department. In the reply provided by the Department, and as indicated in the answer given by Miss Vivian LAU, the Director, in the special meeting of the Committee on 11 April, the figures at Annex II only include the amount of household waste collected by the refuse collection points of the Department. Will the Department provide the total amount of waste collected or cleared by its cleansing sections from other sources (such as through street cleansing)?
- 2) Why can't the Department provide the figures on the amount of waste handled by its refuse collection points?
- The Department has indicated that information on the services provided by the contracts is available at a website (https://www.gldpcms.gov.hk/etb\_prod/jsp\_public/sm/ssm00407r.jsp), while the maps showing the service areas of the contracts can be found in relevant tender documents. I have visited the said website and found that the tender documents can only be accessed after logging in by registered users, and the prerequisite for opening an account is a valid Business Registration Certificate. Therefore, I am not able to obtain the maps showing the service areas of the contractors. Will the Department provide the maps showing the areas served by its contractors and in-house units respectively?

Reply:

The information sought is provided as follows –

- 1) The statistics at Annex II of Reply Serial No. FHB(FE)126 is the amount of refuse collected by the Food and Environmental Hygiene Department (the Department) including its waste collection services contractors at public refuse collection points (RCPs), residential developments (including public housing estates) and other government venues where the Department provides direct collection services. It includes both household waste and street waste collected by the Department. Breakdown for street waste collected is not available.
- 2) The estimated daily amount of refuse collected by permanent off-street and village-type RCPs of the Department is provided at Annex I and II respectively.
- 3) Maps showing the service areas of the street cleansing contracts are provided at Annex III.



Boundary of Lantau Island






Boundary of Contract Area in Mong Kok District (West)



**Boundary of Sham Shui Po District** 




Boundary of Contract Area in Sham Shui Po District (West)






Map Showing the Boundary of Contract Area in Kowloon City District (North)


Map Showing the Boundary of Contract Area in Kowloon City District (South)


Boundary of Contract Areas for Tsuen Wan Township and Remote Area






Boundary of Contract Area for Penny's Bay and Sunny Bay








Map showing the boundary of Contract Area A of Tuen Mun District



Map showing Contract Area C in Tai Po District






#### Location Map showing Ko Lau Wan and Tan Ka Wan




Contract Area B - Location 2 - Hang On Station of Ma On Shan MTR (Sai Sha Road)




Contract Area B - Location 3 - Tai Shui Hang Station of Ma On Shan MTR (Hang Tak Street and Hang Tai Street)






Boundary of Sai Kung Remote Area




Boundary line of the Northern Portion of Sai Kung Remote Area





- 1) Will the Department have a dedicated team to review the footage captured by the Internet Protocol (IP) cameras? If yes, what are the manpower and annual expenditure to be involved?
- 2) How long will the footage captured by the IP cameras be stored? Will the Department restrict the use of the footage?

Reply:

The information sought is provided as follows -

- 1) All footage captured by the Internet Protocol (IP) cameras goes through computer video analysis whereby illegal acts of refuse deposit can be identified for verification by the contractors. Staff of the Food and Environmental Hygiene Department (the Department) rely on the footage captured to collect evidence and institute prosecution against fly-tippers. Moreover, the Department can analyse the timing and patterns of the illegal acts to formulate more effective enforcement operations. The Department has no dedicated team to review the footage captured by the IP cameras.
- 2) Footage without suspected cases being captured are normally deleted after random checking (within 1 month). For footage with cases detected, they will be kept until the investigation or prosecution action is completed. Footage will only be used for the purpose of detection, prevention and prosecution of public cleanliness offences. The Department will only consider providing the footage to other departments upon request and in accordance with section 58 of the Personal Data (Privacy) Ordinance (Cap. 486).

The Food and Environmental Hygiene Department (the Department) will adopt the new enhancement measures for service tenders issued on or after 1 April 2019 to protect outsourced non-skilled workers employed by its service contractors. The new enhancement measures will be applied upon renewal of the contracts.

To benefit non-skilled workers engaged in the service contracts during the transitional period between the announcement of the new policy in October 2018 and the effective date of 1 April 2019, the Department has negotiated with the service contractors concerned to incorporate relevant new enhancement measures into the service contracts by making top-up payments on a reimbursement basis for the additional costs incurred.
