Information on Projects Completed in the Financial Year 2016-17

This information note provides an annual report on the outturn expenditure for capital works projects completed (i.e. with accounts finalised) during the financial year 2016-17. Such information has been provided to Members on an annual basis since 1998-99.

- 2. During 2016-17, the accounts for 40 projects in Category A were finalised. A list showing their approved project estimates (APE) (or the revised APE where applicable) and the final outturn expenditure is at Enclosure 1. A summary of the outturn expenditure for individual heads of expenditure is at Enclosure 2.
- 3. Of these projects, the average final outturn expenditure represented some 75.8% of the final APE. The corresponding statistics for 2014-15 and 2015-16 were 89.3% and 87.1% respectively.

^{*} On 10 June 2011, FC approved the upgrading of **114KA** entitled "Purchase and conversion of industrial building for Water Supplies Department facilities" for purchasing and coverting an industrial building for relocation of the Water Supplies Department (WSD) facilities in Mong Kok. However, no suitable industrial building satisfying WSD's operational requirements and within budget could be identified despite the extensive search by WSD's consultants. To facilitate an early release of the Mong Kok site, Development Bureau decided to put forward the project **117KA** "Relocation of New Territories West Regional Office and Water Resources Education Centre of Water Supplies Department to Tin Shui Wai" for construction of a new building for the WSD facilities in lieu of **114KA**. **114KA** was therefore not pursued as **117KA** was approved by FC on 26 June 2015. This development was reported to the Public Works Subcommittee vide PWSC(2015-16)15.
