#### **Council meeting of 24 October 2018**

### Debate and voting arrangements for two motions under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382)

Further to LC Paper No. CB(3) 19/18-19 dated 8 October 2018 regarding Hon Claudia MO's motion to be moved under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382) at the above meeting, Members are invited to note that the President has given permission for Hon LAM Cheuk-ting to move the attached motion under Cap. 382 at the above meeting and directed that the motion be printed in the terms in which it was handed in on the Agenda of the Council.

- 2. As the subject matter of both Hon Claudia MO's and Hon LAM Cheuk-ting's motions is concerned about the construction works of the Shatin to Central Link, the President has directed that **a joint debate** be held on the two motions and then they be **voted upon one by one**. To assist Members to debate, I set out below the relevant proceedings under which the President will:
  - (a) first call upon Hon Claudia MO to speak and move her motion, and then propose the question on her motion;
  - (b) call upon Hon LAM Cheuk-ting to speak, but he may not move his motion at this stage;
  - (c) call upon the public officer to speak;
  - (d) invite other Members to speak;

- (e) call upon Hon LAM Cheuk-ting to speak again;
- (f) call upon the public officer to speak again;
- (g) call upon Hon Claudia Mo to reply, and order that the debate comes to a close;
- (h) put to vote the question on Hon Claudia MO's motion; and
- (i) irrespective of whether Hon Claudia MO's motion is passed, invite Hon LAM Cheuk-ting to move his motion and forthwith propose and put to vote the question on his motion.
- 3. Members are invited to note that each Member may only speak once in the above joint debate and the speaking time limit for each Member is 15 minutes. Hon Claudia MO and Hon LAM Cheuk-ting as motion movers will have another 15 minutes to speak again before the motions are put to vote. The public officer will not be subject to any speaking time limit.

# Motion under the Legislative Council (Powers and Privileges) Ordinance to be moved by Hon LAM Cheuk-ting at the Council meeting of 24 October 2018

#### **Wording of the motion**

That this Council appoints a select committee to inquire into matters relating to the MTR Corporation Limited's alleged concealment of the substandard construction works and alternations to the construction drawings of the Shatin to Central Link ("SCL"), alleged failure to suspend the construction works and notify the public when the settlement of some monitoring points is found to have exceeded the pre-set trigger levels during the construction of 8 stations along SCL, and subsequent proposal of relaxing the pre-set trigger levels for temporary suspension of works of the monitoring points near the construction site of the Exhibition Centre Station of SCL, and other related matters, and that in the performance of its duties the committee be authorized under section 9(2) of the Legislative Council (Powers and Privileges) Ordinance (Cap. 382) to exercise the powers conferred by section 9(1) of that Ordinance.
