## Report No. 7/18-19 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

## Purpose

3. The House Committee formed a subcommittee to study items (1) and (2) in detail at its meeting on 19 October 2018. The Subcommittee reported its deliberations at the House Committee meeting on 30 November 2018 vide LC Paper No. CB(4)257/18-19.

The House Committee formed four subcommittees to study items (3) to 4. (19), item (20), item (21), as well as items (22) to (26) respectively in detail at its meeting on 26 October 2018. The first, third and fourth Subcommittees reported its deliberations at the House Committee meeting on 30 November Paper 2018 vide LC Nos. CB(4)258/18-19, CB(1)226/18-19 and CB(2)328/18-19 respectively. The second Subcommittee made a verbal report at the House Committee meeting on the same day, and provided Members with a written report vide LC Paper No. CB(1)265/18-19 on 5 December 2018.

5. A subcommittee was proposed to be formed to study items (32) to (35) in detail at the House Committee meeting on 23 November 2018. Since only two Members have signified to join the proposed subcommittee by the deadline for signification of membership, it cannot be formed by virtue of House Rules 21(b) and 26(f).

6. A subcommittee was proposed to be formed to study item (37) in detail at the House Committee meeting on 30 November 2018. Since no Member has signified to join the proposed subcommittee by the deadline for signification of membership, it cannot be formed by virtue of House Rules 21(b) and 26(f).

7. Regarding items (27) to (31) and (36), the House Committee considered it not necessary to form any subcommittee to study these six items of subsidiary legislation.

- Note: (a) The House Committee formed a subcommittee to study the Antiquities and Monuments (Declaration of Monuments and Historical Buildings) (Consolidation) (Amendment) Notice 2018 (L.N. 224/2018) at its meeting on 23 November 2018. The President has given permission for Dr Hon KWOK Ka-ki, Chairman of the Subcommittee, to move a proposed resolution at the Council meeting of 12 December 2018 to extend the period for amending this item of subsidiary legislation to the Council meeting of 9 January 2019.
  - (b) The House Committee formed a subcommittee to study the following three items of subsidiary legislation at its meeting on 7 December 2018. Hon Starry LEE, Chairman of the House Committee, has given notice to move a proposed resolution at the Council meeting of 12 December 2018 to extend the period for amending these three items of subsidiary legislation to the Council meeting of 23 January 2019. (c) The House Committee formed a subcommittee to study the Fugitive Offenders (France) Order (L.N. 240/2018) at its meeting on 7 December 2018. Hon Starry LEE, Chairman of the House Committee, has given notice to move a proposed resolution at the Council meeting of 12 December 2018 to extend the period for repealing an order referred to in section 3(3) of the Fugitive Offenders Ordinance (Cap. 503) pursuant to section 3(5) of that Ordinance to the Council meeting of 23 January 2019.
