#### <u>Action</u>

#### I Election of Chairman

#### Follow-up actions to be taken by the Administration

4. <u>The Administration</u> was requested to provide the following information:

*Validity period of an excavation permit ("permit period")* 

- (a) elaboration of the principles and criteria adopted by the Highways Department ("HyD") in determining the initial permit period for different types and scales of road excavation works when conducting permit period assessment ("PPA") for excavation permit applications;
- (b) background of the formulation and implementation of the PPA process, including in particular when it was formulated, the recommendations made by the Hong Kong University of Science and Technology and the Hong Kong Polytechnic University on the PPA principles and criteria, and any subsequent review(s) conducted so far;

Charging of economic costs for extension of permit period

- (c) an explanation on the calculation and charging of the economic costs for extension of the permit period due to delayed excavation works, including:
  - (i) the current basis of the calculation, and whether HyD would consider factoring in the inconvenience caused to the public and loss of business of the affected shops in the vicinity in

- the calculation; if it would, the details; if not, the reasons why; and
- (ii) whether the charging of economic costs was based on the number of days of delay; whether HyD had the discretion to deduct the number of days of delay to be charged or grant refund of the economic costs paid if the delay is caused by justifiable reasons; if so, categories of the justifiable reasons, and the legal basis for taking into consideration such justifiable reasons in making deduction or refund under the Land (Miscellaneous Provisions) Ordinance (Cap. 28) and the Land (Miscellaneous Provisions) Regulations (Cap. 28A); and

Exploring the use of common utility tunnels

(d) the expected completion time of the consultancy study on the use of common utility tunnels.

(*Post-meeting note*: The Administration's response was issued to members vide LC Paper No. CB(1)182/18-19(02) on 19 November 2018.)

#### Date of next meeting and legislative timetable

5. <u>Members</u> agreed that the next meeting of the Subcommittee be tentatively scheduled for Tuesday, 20 November 2018 to discuss the Administration's response to the issues raised at this meeting, and to continue to study the Land (Miscellaneous Provisions) (Amendment) Regulation 2018 ("Amendment Regulation").

6. <u>The Subcommittee</u> noted that the scrutiny period of the Amendment Regulation would expire at the Council meeting of 28 November 2018. To allow sufficient time for the Subcommittee to consider the supplementary information provided by the Administration and to study the Amendment Regulation, the Subcommittee agreed that the Chairman would move a motion at the Council meeting of 21 November 2018 to extend the scrutiny period to the Council meeting of 9 January 2019. Members noted that, upon extension of the scrutiny period, the deadline for giving notice of motion to amend the

Amendment Regulation would be 2 January 2019. <u>The Chairman</u> would report the deliberations of the Subcommittee to the House Committee at its meeting on 14 December 2018.

(*Post-meeting note*: At the Council meeting of 21 November 2018, the Council passed a motion to extend the scrutiny period of the Amendment Regulation to the Council meeting of 9 January 2019.)

		(a) the average validity period of XPs ("permit period") for standard excavation works programmes had been shortened in recent years as a result of the improvements made by the Highways Department ("HyD") in the permit

		(c) the Administration adopted a positive attitude on the proposed use of CUT in new development areas where it was justified and cost-effective to do so. In fact, HyD had commissioned a consultant to conduct a feasibility study in mid-2018 to review the implementation of CUT in new development areas.

		The Administration responded that:  (a) for streets maintained by HyD, an XP applicant was required to submit a construction programme and work activities for the proposed excavation works for HyD's approval. For standard works programmes, the applicants should use the standard PPA templates provided in the XP Management System ("XPMS"), which was implemented by HyD for the management of XP applications, to generate their construction programmes for submission to HyD. The standard PPA templates provided a standard duration for each excavation works activity for specific type of excavation works concerned;	
		(b) HyD had commissioned the Hong Kong University of Science and Technology ("HKUST") (the review was completed in 2012) and the Hong Kong Polytechnic University ("HKPU") (the review was completed in 2013) to review the PPA method for utility trench works and other excavation works respectively; and

		(c) to reflect the updated economic loss due to traffic delay caused by the excavations and to maintain sufficient incentive to the excavation permittees to complete their works as soon as possible, the economic costs payable for extension of the permit period were proposed to be increased by 7% to 8%.

		(b) HyD was exploring with the Lands Department the possibility to make use of their existing data sharing systems, such as Geospatial Information Hub and GeoInfo Map, to share the underground utility information and the feasibility todevelop an effective management and monitoring system on underground space occupation;	
		(c) HyD had commissioned a consultant to conduct a feasibility study in mid-2018 to review the implementation of CUT in new development areas. HyD would closely monitor the

		(d) in an effort to improve the overall inspection coverage for XP sites, HyD had enhanced the Audit Inspection Management System in July 2018 so that any permit sites without Advance Notification submission but with permit duration elapsed by 50% would be scheduled for inspection. HyD would regularly monitor the effectiveness of the modification;	
		(e) HyD would regularly compile statistical data to closely monitor the processing of Completion Notice and submission of site photographs and test reports by utility undertakings ("UUs"). Demerit points would be assigned to UUs under DPS with sanctioning measures for any overdue submissions; and
