| | | The Administration's elaboration on measures that had been or to be taken to raise different sectors' awareness of the licensing scheme, including providing a dedicated enquiry line (number: 3107–2939), organizing briefings and meetings for relevant professional bodies and sectors (e.g. the two-day Symposium on Healthcare Facilities Management 2019 ("the Symposium") on 19 and 26 January 2019 and the upcoming meetings with the Hong Kong Private Hospitals Association and the Hong Kong Dental Association on invitation); and sending letters to relevant stakeholders to keep them posted of the development. | |
| 002743 - 003846 | Chairman Mr SHIU Ka-fai Admin | In response to Mr SHIU Ka-fai's enquiry, the Administration explained that given the nature of the provisional day procedure centre licence and provisional clinic licence, it would be appropriate to specify the date on which the Ordinance was | |

| | | Referring to section 138 of the Ordinance which provided that subject to certain conditions, a clinic was not required to comply with the requirements of having a direct and separate entrance as set out in section 67 of the Ordinance during the validity period of its provisional licence, Mr SHIU Ka-fai enquired as to whether section 138 would still apply if the lease of the premises of the clinic concerned was renewed before the commencement of application for clinic licence. The Administration affirmed that the provision would apply as long as there was no change in the operator of the clinic. | |
| 003847 - 004424 | Chairman Admin | The Chairman's concern about the Administration's work plan to process the applications for day procedure centre licence; and his question about whether the first batch of day procedure centre licences which might take effect in early 2021 covered only the provisional day procedure centre licences. It was expected that the PHF Office would have six to eight months' time before issuing the first batch of provisional day procedure centre licences. | |

| | Wil Stille Ka-tai | In response to Dr KWOK Ka-ki's enquiry, the Administration advised that examples of documentary proof of a day procedure centre or a clinic operating on the specified date were a copy of Business Registration Certificate showing that medical services concerned were carried out on the premises by the applicant, records of procurement or maintenance of drugs and medical equipment, other licence(s) relating to the provision of medical services concerned, and records of employment or appointment of healthcare staff. | |
| | | Dr KWOK Ka-ki's views that the Administration should make public as early as possible the licence application procedure, including the types of documents that an applicant had to provide to prove that the day procedure centre or the clinic concerned was already in operation on the premises on the specified date. Separately, those licence applications not being made by a person who operated a day procedure centre or a clinic on the specified date (who could continue to operate the facility with a provisional licence) should be processed first, such that the facilities concerned could commence operation at an earlier time. | |
| 011540 - 012850 | Chairman Admin | The Chairman's further enquiry about the time required by the PHF Office to process an application for and issue of a provisional licence and a full licence under the new regime. | |
| | | The Administration's advice that it was difficult to estimate at this stage the time required to process an application. That said, to ensure smooth processing of licence applications upon the full implementation of the new regulatory regime (i.e. when all PHFs were required to operate with licences or letters of exemption), applicants for a day procedure centre licence should submit the application with all required documents to the PHF | |

| 012851 - 020018 | Chairman Mr SHIU Ka-fai Admin Dr KWOK Ka-ki | On Dr KWOK Ka-ki's concern about the establishment of the PHF Office, the Administration advised that it would seek to increase by around 100 staff in phases, from the existing establishment of about 40 staff in the PHF Office involved in licensing work, in order to support the new regulatory regime. | |
| | | Dr KWOK Ka-ki and the Chairman's strong view that the Administration should work out a pledge in respect of the time required for the PHF Office to process an application so as to facilitate persons intending to operate a day procedure centre or a clinic to have a better estimation of when the facility could commence operation, as well as the rental and staff expenditure to be incurred before the commencement of operation of the facility. | |
| | | The Administration made the following response: | |
| | | (a) prior to the issuance of a full licence, staff of the PHF Office would inspect the premises of the PHF to which the application related upon receipt of notification of compliance with the relevant licensing requirements from the applicant. Where necessary, the applicant concerned would be required to make amendment to the application, or alternation or improvement to the premises. Follow-up inspection(s) by staff of the PHF Office would be conducted upon receipt of the applicant's notification on the readiness for re-inspection after alteration or improvement. A full licence would be issued when full compliance with the licensing requirements was confirmed; and | |
| | | (b) consideration would be given to setting the target processing times for different stages of licence application, such as the target time to conduct verification inspection upon receipt of notification of compliance with the relevant licensing requirements from the applicant, in the light of the actual | |

| | | Mr SHIU Ka-fai urged the Administration to organize sector targeted briefings to facilitate individual sectors, in particular the beauty industry, to better understand those provisions relating to their operation. Dr KWOK Ka-ki suggested that quarterly briefings should be conducted at different districts to help relevant stakeholders to prepare for the new regime. The Administration assured members that efforts would continuously be made to raise different sectors' awareness of the new licensing scheme through different channels. | |
