I. Meeting with the Administration

The Subcommittee deliberated (index of proceedings attached at **Annex**).

2. The Subcommittee received oral representations from 100 deputations/individuals attending the meeting. Sixty deputations/individuals generally supported the Prohibition on Face Covering Regulation ("the Regulation") while 40 deputations/individuals held opposite views.

3. The major views and concerns expressed by the deputations/individuals supporting the Regulation are summarized as follows:

- (a) there was an imminent need for the Regulation to handle protests and violent incidents in the past few months. The demonstrations and disturbances had severely affected the rule of law, public order, livelihood and economy of Hong Kong. Besides, a number of protesters had become radical protesters as they perceived that they could conceal their identities and evade police investigation and legal responsibilities if they were suited up and masked;
- (b) the Government should strengthen law enforcement work and raise relevant penalty, with a view to stopping violence and restoring peace to the society as soon as possible;
- (c) laws similar to the Regulation could be found in the permanent criminal codes in other western democratic jurisdictions, such as Canada, France, Sweden, Spain, Denmark, Norway, Germany and Austria; and
- (d) the Regulation had given due consideration to the human rights guarantees in the Basic Law ("BL") and the Hong Kong Bill of Rights Ordinance (Cap. 383) ("HKBORO"), including the rights of freedom of expression, peaceful assembly, privacy and freedom of religion. These rights were not absolute and might be subject to restrictions.

4. The major views and concerns expressed by the deputations/individuals opposing the Regulation are summarized as follows:

- (a) the prohibition on the use of facial covering could not prevent or deter the outbreaks of violence in the course of protests. The Government should instead study the causes of the deep-rooted conflicts in Hong Kong, with a view to addressing the problems squarely and responding to demands from the society;
- (b) the prohibition on the use of facial covering in a public meeting or public procession for which a Letter of No Objection had been issued by the Commissioner of Police would impair the freedom of speech and freedom of assembly enjoyed by members of the public under BL 27;
- (c) there was a genuine need to use facial covering in public meetings, assemblies and processions for privacy protection, health and safety reasons; and
- (d) concerns had been raised on the legality, constitutionality and proportionality of the Regulation. It was pointed out that anti-mask legislation in many overseas jurisdictions was enacted in the form of primary legislation instead of through subsidiary legislation. Concern had also been raised as to whether the making of the Regulation by the Chief Executive ("CE") in Council was compatible with BL, given that CE in Council was not empowered to enact, amend or repeal laws in accordance with BL.

5. In response to the views and concerns of the deputations/individuals attending the meeting, the Administration made the following points:

- (a) in the four months from early June to early October 2019, more than 400 demonstrations, processions and assemblies arising from the proposed amendments to the Fugitive Offenders Ordinance (Cap. 503) had been staged, with a significant number of public order events ending up in outbreaks of violence in various districts. These incidents had caused injuries to more than 1 100 people. Radical protesters caused large scale harm to life and property, assaulted people holding different opinions flagrantly, used different kinds of dangerous tools and objects, threw petrol bombs, set fires and blocked roads. These acts had severely endangered public peace and public safety, as well

as affected the rule of law, livelihood and economy of Hong Kong;

- (b) in these violent incidents, many of the protesters were all suited up and masked to conceal their identities, which enabled them to evade police investigation and emboldened them to continue with their illegal acts;
- (c) as an occasion of public danger was present, CE in Council made the Regulation in accordance with section 2(1) of the Emergency Regulations Ordinance (Cap. 241) to prohibit the use of facial covering under certain circumstances, with a view to deterring and reducing violent acts committed by persons with facial covering, as well as protecting public safety and restoring public peace;
- (d) a person at an event regulated by section 3(1) of the Regulation would have defence for using a facial covering if the person had lawful authority or a reasonable excuse (e.g. a journalist) was engaged in employment and was using the facial covering for the physical safety of the person while performing an act or activity connected with the employment). If a person was using the facial covering for religious reasons or a pre-existing medical or health reason, the person would also have a reasonable excuse under section 4(3) of the Regulation;
- (e) the Regulation would not impair the very essence of the freedom of speech and freedom of peaceful assembly enjoyed by members of the public because they were still free to take part in lawful and peaceful public order events without using facial covering;
- (f) the Regulation had given due consideration to the human rights guarantees in BL and HKBORO. It was pointed out that these rights were not absolute and might be subject to restrictions;
- (g) the Regulation was a proportionate means to achieve the legitimate aim, and a reasonable balance had been struck between the societal benefits of the Regulation and protection of individuals' rights; and

- (h) apart from making the Regulation, the Government was making efforts in implementing the "four actions" announced by CE in early September 2019. These include: withdrawing the Fugitive Offenders and Mutual Legal Assistance in Criminal Matters Legislation (Amendment) Bill 2019; providing full support to the work of the Independent Police Complaints Council to publish its first phase report regarding the large-scale public order events by end 2019; reaching out to the community to start a direct dialogue from September 2019; and continuing to invite community leaders, professionals and academics to independently examine and review society's deep-seated problems and to advise the Government on finding solutions.

6. The Subcommittee requested the Administration to provide the following information:

- (a) the background leading to and the legislative intent of introducing similar laws imposing prohibition on face covering in other western democratic jurisdictions as mentioned in the Administration's response (LC Paper No. CB(2)74/19-20(02));
- (b) the reasons for not making "without lawful authority or reasonable excuse" as an element of the offence under section 3(2) of the Regulation; and
- (c) the number of people arrested but could not be prosecuted because of the difficulties in proving their identities with the use of facial covering.

II. Any other business

7. There being no other business, the meeting ended at 5:41 pm.
