- lack of hope for any kind of future for the Chinese White Dolphin and Finless Porpoise populations whose numbers are rapidly declining and are close to everlasting extinction.

- the reclamation will encroach on the foraging grounds of the white-bellied sea eagles and impact on their breeding success as well as cause destruction to coral habitats that are of research interest related to climate change.

- Reclamation is ecologically devastating both to the natural area where the sand comes from as well as to its destination. This is one of the largest proposed reclamation projects in the world and the amount of sand required will cause significant ecological harm.

- There is the potential that the connectedness of islands will bring invasive species to prey upon rare species only found on these islands (e.g. the Bogadek burrowing lizard)

Economical:

- the livelihoods of local fishermen will be at risk due to permanent loss of fishing grounds.

- the proposed costs of the project are shortsighted and a huge gamble with little evidence to suggest that this kind of long-term plan for HK will be required in the future. The cost of reclamation sand has doubled in the last year and it's intermittent availability has slowed existing projects. There is little experience/knowledge of using construction waste as an alternative fill material. Recently we have seen the collapse of wave-barriers around the Zhuhai-Macau bridge islands where construction waste was used.

Climate Change:

- the long-term success of this project would be in jeopardy due to rising sea levels

- It is necessary that the HK Govt should first complete a carbon audit to carefully assess the carbon footprint of building the artificial islands before

going ahead with this project as is HK's commitment under the Paris Climate Agreement.

I am a Hong Kong citizen, resident, taxpayer and parent of two children under 6 years old. I am a registered voter for the Southern District and the Legal functional constituency. I want my children to grow up in a strong and stable Hong Kong, Greater Bay Area ("GBA") and World which is better in every way than it is right now.

In my view, the Lantau Tomorrow Vision has an exciting possibility - as a pilot to achieve a **transformation to ecological civilization**.

1. Principle of ecological civilization for Lantau development

The GBA has a current population of 68 million forecast to reach 100 million by 2035. It is already the biggest Bay Area in the world. How can it also become the most valuable and productive?

In my view the answer is clean air, clean water, jobs, housing, education, entrepreneurial opportunity and access to nature. This will nurture good citizens and 21st century knowledge workers. This is the principle of a transformation to ecological civilization. It follows the 13th Five Year Plan, the Greater Bay Area Plan, Hong Kong 2030+ Plan and the United Nation Sustainable Development Goals.

Right now, every major financial and industrial city is struggling to achieve ecological civilization according to carbon emissions, air quality, water quality, population health, crime and other indicators. For example the PM2.5 for Central London exceeds WHO safety levels and violent crime is starting to rise.

GBA is unique for its size, as well as its location within the Indo-Burma Biodiversity Hotspot. By pursuing ecological civilization GBA could become the pre-eminent example in the world of Green-Blue Urban Development. In fact Hong Kong and the GBA already have an advantage due to the world leading public transport network and valuable natural assets. It follows that the principle of ecological civilization must be applied to the Lantau Tomorrow Vision. It should underlie the stated goals of providing adequate housing and recreation for residents of Hong Kong and the GBA. We should chase this opportunity is to showcase to the world, through technology and innovation, that zero carbon emissions green-blue growth is possible by nurturing a transformation to ecological civilization in the GBA starting from Lantau.

2. Evaluating and capitalizing on the environmental assets of Lantau

Based on the principle of transformation to ecological civilization of GBA, the value of Lantau is as a carbon sink for the GBA, last remaining green wilderness, country park and is an undervalued asset as such. It also incorporates a little-studied marine wilderness in the GBA for species in South China including the endangered Chinese White Dolphin and Finless Porpoise, which are iconic symbols of the Pearl River. It is important to conduct scientific and economic appraisal of the ecosystem and cultural services of Lantau for GBA to incorporate into planning.

Within the GBA, my view is that Lantau has a role to be preserved and further restored (including re-introducing species such as incense trees, Chinese pangolin etc) as a unique South China National Park and City Level United Nations Biosphere Reserve. A Biosphere Reserve is a framework with exclusion zones for conservation, but also includes zones permitting recreational/ economic use of the protected area as pilot for sustainable development. Lantau could incorporate some planned, restricted areas of low environmental impact, high tech, creative/ knowledge worker industry. One example is the Lake District, UK which is protected as a famous national park but contains thriving industry and innovation.

The creation of a South China National Park and City Level UN Biosphere Reserve should be the focus of the Lantau Conservation Fund. Further funding could be raised through Government issuing Climate Bonds for long term international institutional investment (see Climate Bonds Initiative standards for land use and forests).

Meanwhile, in my opinion it is not appropriate to develop Lantau into a third CBD for Hong Kong when other cities in the GBA are in greater need of investment for upgrading commercial and residential infrastructure, especially with view to low carbon building.

3. Objection to Land Reclamation in Lantau & Opportunity for Low Carbon Climate Resilient Brownfield Development

Hong Kong has struggled with land supply and Hong Kong has succeeded many times in the past to expand through land reclamation including Hong Kong's Waterfront and building one of the world's busiest and best airports on Lantau.

But in 2018 the Intergovernmental Panel on Climate Change released their aggressive new Climate Goals. The story of a 16-year old girl, Greta Thunberg, protesting against climate inaction dominated the past World Economic Forum at Davos and global attention. There is a global realisation towards low carbon development for the need to shift and investment. Premier Li Keqiang has called this a phase of "high quality growth", under the concept of "new urbanisation" which is compact, green, low carbon and smart urban development.

The circumstances have reached a tipping point in 2019 meaning that the principle of ecological civilization and role of Lantau in GBA, land reclamation is would no longer be a favourable solution to the problems posed by housing and recreation in Lantau and GBA. In my view, proceeding now despite the recent shift in global and national policy would reflect badly on Hong Kong as a sophisticated economy and negatively impact the economic development of GBA, and ability to attract and retain skilled knowledge workers.

To meet housing needs the panel may consider brownfield redevelopment in Hong Kong ex Lantau and wider GBA. There is a supply side shortage of suitable climate bonds as institutional investors are pressured to move towards investment in low carbon products. The Climate Bonds Initiative has a clear framework for low carbon building development (commercial and residential) which could be applied towards brownfield redevelopment in Hong Kong ex Lantau and wider GBA. This supports Hong Kong's development as a global financial capital for green financing.

Such climate bonds could also make financing available for low carbon tourism and recreation infrastructure on Lantau including waste treatment (sewage, compost, recycling etc) facilities, renewable energy, network of cycling trails, beach facilities, as well as towards maintenance of South China National Park and City Level UN Biosphere Reserve.

In Summary:

- The development of Lantau can be used as a catalyst in the transformation to ecological civilization of the Greater Bay Area.
- However there has been a global tipping point in the past six months in view of the new IPCC targets, as well as aggressive new national targets on emissions, and national recognition of the need for high quality growth and new kind of urbanisation.

- The need for housing should be shifted to brownfield only sites in Lantau, Hong Kong and adjacent GBA cities, land reclamation should now be avoided at all costs. This pivot would be applauded globally.
- Investment should be diverted to upgrading other cities in GBA for low carbon development.
- Further capital for low carbon brownfield development and development of low carbon recreational and tourism infrastructure or low carbon forestry and land use can be raised through District-level, Hong Kong or GBA issued Climate Bonds. There is supply side shortage globally.
- Lantau can be made into a unique and ambitious South China National Park and internationally recognised City Level UN Biosphere Reserve supporting sustainable, low impact, high tech industry.
- The overall outcome would be a transformation to ecological civilization and high-quality growth of world's biggest and greenest Bay Area, while meeting or exceeding Hong Kong and GBA's targets on urban carbon emissions.

Please record this email as my formal submission to The Panel on Development on the topic of "Studies related to artificial islands in the central waters".

I urge the Panel on Development of LegCo to reject this proposal for the following reasons:

1. The government is trying to mislead the people of Hong Kong about the true nature of this project as has been demonstrated by the clever trickery of associating it only with the Lantau area e.g. East Lantau Metropolis; Lantau Vision Tomorrow, so that people living elsewhere in Hong Kong are deceived into believing that it is not a Whole of Hong Kong issue.

2. The key reason for building the artificial islands around Kau Yi Chau is to "capitalise on Lantau's geographic advantage" to create a new transport network connecting cities in China with Hong Kong. The need for this new network of roads and railways between China and Hong Kong has not been researched or proven. This proposal amounts to using a substantial proportion of Hong Kong's fiscal reserves to singlehandedly fund a symbolic link with China. The Paper (PWP Item No. 768CL - Studies related to Artificial Islands in Central Waters) even states that these transport links "would otherwise not have a case" if the artificial island (which is not needed for land or housing) were not constructed.

3. The Paper makes frequent reference to the report of the Task Force on Land Supply (TFLS). This self serving body and its associated reports have no credibility as the Task Force was specifically selected to represent those who would benefit from the development of Lantau and any independent or objective contributions were suppressed.

4. The Paper tries to justify donating HK\$1 trillion of its people's money to overseas developers and construction companies with banal cliches about the public "living and working in contentment and improving our livelihood". These trite feelgood statements are insulting to our Legislators and the people of Hong Kong because they are cynically aimed to distract attention from the complete absence of concrete measures to address the

Territory's real social needs.

The plan is unbalanced in regards to conservation of natural land, animals and resources. We feel your data leans towards the benefit of contractors and the business sector, which has no consideration for the true needs of the Hong Kong people. Natural parks, mountains and beaches have been overshadowed by greed, investment and unregulated tourism.

The government continues to say Hong Kong people are in support of this plan but these statistics should be made public to insure no corruption is already taking place. Knowing a bit about land supply, in our eyes, land that has been abandoned or held by the Heung Yee Kuk for example, would be a good source of brown land to develop.
