Background brief prepared by the Legislative Council Secretariat for the meeting on 21 January 2019

Vacancy situation in public markets and related issues

Purpose

This paper provides background information on the vacancy situation in public markets and related issues, and summarizes the major views and concerns expressed by members of the Subcommittee on Issues Relating to Public Markets ("the Subcommittee") on the subject in the Sixth Legislative Council ("LegCo").

Background

2. In 2008, when the Panel on Food Safety and Environmental Hygiene discussed with the Administration its review of the provision of public markets in Hong Kong, the Panel members were advised that vacancy rate at 60% and above for three consecutive year and with deficit had proven to be effective indicators in identifying markets with viability problems.¹ In the process of its review of public markets with viability problems, the Administration would discuss with the relevant district councils ("DCs") possible improvement proposals. If there were no viable options to improve the viability of the markets, the Administration would pursue the possibility of market closure in consultation with the relevant DCs and returning the vacated building structures

and land to the Government for other uses. The Administration further advised that four public markets were identified with viability problems, namely Bridges Street Market in Central and Western District, Mong Kok Market in Yau Tsim Mong District, Kwong Choi Market in Tuen Mun District and Tang Lung Chau Market in Wan Chai District. These four public markets were subsequently closed down.

3. During the deliberations of the Subcommittee on Issues Relating to Public Markets formed in the Fifth LegCo, the Administration advised that in order to boost the occupancy rate of public markets, FEHD had since February 2009 lowered the upset auction prices to 80% and 60% of the open market rental for stalls which had been left vacant for six months and eight months respectively. In addition, FEHD had also widened the trade mix by introducing service trades, light refreshment and bakery stalls since July 2009, and started to let out small stalls through short-term tenancies on a trial basis since October 2010.

4. According to the Administration, as at 31 March 2018, FEHD managed 99 public markets. Among them, 35 were standalone wet markets, 39 comprised both a wet market and a cooked food centre, and 25 were standalone cooked food markets. Out of a total of 14 086 stalls, 12 779 (or 90.7%) were rented. A table setting out the number of vacant stalls and vacancy rates of individual public markets from 2015 to 2017 is in **Appendix I**.

Major views and concerns of members of the Subcommittee

5. Members' major views and concerns on the subject are summarized in the ensuing paragraphs.

Vibrancy of public markets

6. Pointing out that a number of stalls were inactive and used for storage or other purposes, members expressed concern about the vibrancy of public markets and urged the Administration to take measures to enhance the vibrancy and patronage of public markets. Some members considered that stalls being vacant for a long period of time should be put into other uses, and that under-utilized public markets could be converted to other uses. At its meeting on 10 July 2018, the Subcommittee passed a motion requesting the Government to, among others, "conduct a study on setting up planters, gym centres, public clinics, etc. in markets where there are space that has been left vacant for a long period of time, with a view to fully utilizing land resources".²

7. The Administration advised that vibrancy of each public market depended on various factors including competition from fresh provision shops in the vicinity, pedestrian traffic, serving transport network, etc. Nevertheless, the Administration noted that about 20% of all the rented stalls in public markets were selling non-food dry goods such as clothes and footwear, and its observation was that stalls of this type constituted a major source of relatively inactive operation in markets. The Administration was conducting a fundamental review for taking forward the Market Modernization Programme ("MMP"), and considered that hardware and management issues should be dealt with in parallel, in a bid to break the longstanding logjam and find concrete solutions to the problems.

8. Members noted that FEHD had, starting from June 2018, suspended the open auction of public market stalls to make available a certain number of vacant stalls for re-siting stall operators affected by the implementation of MMP. There was a view that if such arrangement was made to facilitate the implementation of MMP, FEHD should expeditiously provide a timetable for taking forward MMP.

Closing down of public market with high vacancy rates

9. Members noted that where necessary, the Administration would consider the need for consolidation of public markets to release precious land resources for more gainful use to better serve the community. However, some members questioned why the Administration would consider doing so, as in their view, more public markets should be built to compete with the markets of Link Real Estate Investment Trust. Members also noted that in the 2017-2018 financial year, Tsuen King Circuit Market and Shau Kei Wan Market were closed down. An enquiry was raised as to whether FEHD had taken into account views and suggestion of residents in the vicinity of Tsuen King Circuit Market that stall tenants scattered on different floors could be relocated to one single floor while the remaining two floors could be vacated for other community uses. A question was also raised as to whether the Administration would consult the public regarding the future use of Shau Kei Wan Market.

10. The Administration advised that when considering whether an under-utilized market was to be closed, FEHD would take into account a host of factors, including vacancy rate, prospects for improvement, availability of alternative sources of fresh provision outlets in the vicinity, and the likely cost-effectiveness of upgrading works, etc. Where it was not possible to revitalize an under-utilized public market, then the Administration would consider consolidating the public market and converting it to other uses. The Administration would listen to the views of the community and the relevant DCs before reaching such a decision. According to the Administration, Tsuen King

Circuit Market, which was closed down in March 2018, would be converted to other community uses.

11. An enquiry was also raised about the use of the site of Mong Kok Market which was closed in 2010. There was a view that the Administration should explore the possibility of putting the site to other uses before it was redeveloped, such as for organizing bazaars. The Administration advised that where a market was closed and the premises were no longer required by FEHD, the vacated building space would be handled according to the established Depending on the circumstances, FEHD might request the procedures. Government Property Agency, the Planning Department or the Lands Department to seek inputs from other government departments on proposals to put the premises to gainful long-term use. As regards the redevelopment of the site of Mong Kok Market, the relevant statutory planning procedure and preparatory works were underway. The Administration would welcome views from the public concerning how the Mong Kok Market building could be utilized before the redevelopment. The Administration adopted a positive attitude towards bottom-up and district-led proposals for organizing bazaars. The proposals would be handled and considered by relevant bureaux and departments according to their established procedures and vetting criteria.

Latest development

12. The Subcommittee will discuss with the Administration the vacancy situation in public markets and related issues at its meeting on 21 January 2019.

Motion passed under agenda item I "Issues relating to the positioning and management of public markets and the Market Modernization Programme" at the meeting on 10 July 2018

That, on issues relating to the positioning and management of public markets and the Market Modernization Programme ("MMP"), this Subcommittee urges the Government to:

- 1. conduct a comprehensive review on issues such as the utilization rate of markets and the lack of air-conditioning ("A/C") systems therein, and expeditiously submit a timetable for implementing MMP, with a view to benefiting the tenants of various markets and the public as early as possible;
- 2. instruct the officials concerned to communicate with the stakeholders of various markets on matters relating to the installation of A/C systems such as the installation of closed A/C systems for meat stalls and depending on the actual circumstances, for stalls selling vegetables, fruits and dried goods;
- 3. conduct a study on setting up planters, gym centres, public clinics, etc. in markets where there are space that has been left vacant for a long period of time, with a view to fully utilizing land resources; and
- 4. consult the stakeholders of various markets on a policy of re-allowing the keeping of cats in markets, with a view to alleviating rodent problem.
