# I. Election of Chairman

## II. Schedule of meetings and items for discussion

2. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

3. With reference to the work plan of the Subcommittee endorsed by the Panel on Health Services, <u>members</u> agreed that the Subcommittee should discuss the following issues at its future meetings:

- (a) cancer screening;
- (b) diagnosis and treatment plan of cancer under the public healthcare system (including the application of integrated Chinese-Western medicine and immunotherapy for the treatment of cancer);
- (c) healthcare manpower and medical equipment for cancer services in public hospitals;
- (d) mechanism for appraisal of cancer drugs for inclusion in the Hospital Authority Drug Formulary and the safety net;
- (e) mechanism for the provision of sustainable and affordable drug treatment for cancer patients with financial needs;
- (f) feasibility of setting up a dedicated cancer fund;

- (g) support for cancer patients and their carers; and
- (h) the role of and support by non-profit making organizations in the promotion, coordination and participation of work for prevention and control of cancer.

4. <u>Members</u> agreed that the Subcommittee should receive public views on the prevention and treatment of cancer at its next meeting to be held in April 2019.
