Legislative Council Panel on Health Services Re-organisation of the Department of Health ("DH")

At the meeting of the Legislative Council Panel on Health Services held on 18 February 2019, Members discussed the DH re-organisation proposal and requested the Government to provide the following information -

- (a) in table form the respective changes in the number of directorate, non-directorate and promotion rank posts of the DH under the re-organisation proposal;
- (b) the respective numbers of prosecution cases instituted in the past three years by the Police or DH against (i) parties involved in private healthcare facilities; and (ii) suspected illegal practice of Western medicine and dentistry.

With information provided by DH, I am authorised to provide the reply as follows –

Administration's Response to (a)

Under the re-organisation proposal, Consultant in-charge Dental Service, Controller, Centre for Health Protection, Controller, Regulatory Affairs and Deputy Director of Health

will report directly to the Director of Health. The increase in the number of directorate and non-directorate posts (including the posts in the promotion rank) under their purview is tabulated below:

Administration's Response to (b)(i)

Under the Hospitals, Nursing Homes and Maternity Homes Registration Ordinance (Cap. 165) and the Medical Clinics Ordinance (Cap. 343), the Department of Health (DH) registers private hospitals, nursing homes and medical clinics subject to conditions relating to accommodation, staffing and equipment. DH has also promulgated the "Code of Practice for Private Hospitals, Nursing Homes and Maternity Homes" and the "Code of Practice for Clinics Registered under the Medical Clinics Ordinance (Cap. 343)" which set out the regulatory standards. Currently, there are 12 private hospitals, 66 nursing homes and 87 medical clinics registered under Cap. 165 and Cap. 343 respectively.

With respect to the private healthcare facilities registered under Cap. 165 and Cap. 343, the numbers of non-compliance cases with the respective code of practice or licensing conditions in 2016, 2017 and 2018 are 25, 19 and 29 respectively. DH has issued regulatory letters to the institutions concerned and monitored their remedial actions.

In the past three years, one case was prosecuted for carrying on a clinic not being registered under Cap. 343, which is an act contravening section 14(1)(a) of Cap. 343.

Administration's Response to (b)(ii)

Should there be suspected illegal practice of Western medicine or dentistry identified via complaints or other sources, DH will refer the case to the Police and provide professional support for their investigation. The numbers of cases of suspected illegal practice referred

and/or with assistance provided to the Police by DH in 2016, 2017 and 2018 are provided below:
