# Progress Report on the Admission Scheme for Mainland Talents and Professionals

(From 1 April 2018 to 30 September 2018)

## I. Employment applications

The Admission Scheme for Mainland Talents and Professionals was implemented on 15 July 2003. Between 1 April 2018 and 30 September 2018, **7 899** entry applications for employment were received (monthly average: **1 317**). In the same period, **7 090** applications were approved, **126** refused and **624** withdrawn by applicant / no further action taken. As at 30 September 2018, **1 804** applications were under processing.
