LEGISLATIVE COUNCIL BRIEF

PUBLIC HEALTH AND MUNICIPAL SERVICES ORDINANCE SETTING ASIDE PLACES FOR USE AS PUBLIC PLEASURE GROUNDS

INTRODUCTION

The Director of Leisure and Cultural Services, in her capacity as the Authority ("Authority") under the Public Health and Municipal Services Ordinance, Cap.132 ("the Ordinance"), manages the public pleasure grounds listed in the Fourth Schedule to the Ordinance. Under Section 106 of the Ordinance, the Authority may, from time to time, by order set aside places for use as public pleasure grounds, and may by order amend the Fourth Schedule.

2. We propose to introduce amendments through the Public Health and Municipal Services Ordinance (Public Pleasure Grounds) (Amendment of Fourth Schedule) Order 2019 (the Amendment Order) to set aside the places specified in Schedule 1 of the Amendment Order for use as public pleasure grounds, to cease to set aside the places specified in Schedule 2 for use as public pleasure grounds and to rename the public pleasure ground specified in the Schedule 3 of the Amendment Order. The Amendment Order is at <u>Annex</u> to this Brief.

JUSTIFICATIONS

3. The proposal to set aside nine venues as public pleasure grounds will enable the Authority to enforce the Pleasure Grounds Regulation in those venues. We also propose to delete four venues from the Fourth Schedule as they cease to be used as public pleasure grounds and to rename one venue.

PLACE TO BE SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

4. The following nine venues will be designated as public pleasure grounds and be included in the Fourth Schedule -

(i) Five newly completed venues that will be opened for public use by the Leisure and Cultural Services Department (LCSD):

- (a) Man Cheong Street Park
- (b) Che Kung Temple Sports Centre
- (c) Silver Mine Bay Viewing Deck
- (d) Siu Lun Sports Centre
- (e) Tuen Mun River (Eastern Bank) Garden
- (ii) Four venues that are taken over from the Home Affairs Department for management by LCSD:
 - (a) Tai Man Street Playground
 - (b) Ha Tsuen Tung Tau Tsuen Sitting-out Area No. 1
 - (c) Lam Hau Tsuen Basketball Court
 - (d) Shing Uk Tsuen Sitting-out Area

PLACES CEASING TO BE SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

5. The following four venues will be deleted from the Fourth Schedule as they have ceased to be public pleasure grounds:

- (i) Ship Street Playground will be handed over to the Lands Department for the "Development Project of Hopewell Centre II".
- (ii) & (iii) Man Cheong Street Community Garden and Yau Tsim Mong Pet Garden have been integrated into the Man Cheong Street Park which will be handed over to LCSD for management.
- (iv) Ting On Street Playground will be handed over to the Hong Kong Housing Society for the redevelopment of Kwun Tong Garden Estate Site II.

RENAMING OF PUBLIC PLEASURE GROUNDS

6. Sham Tseng Temporary Playground is recommended to be renamed as Sham Tseng Playground in order to tie in with the change of land status from temporary land allocation to permanent land allocation. The renaming proposal is supported by the Tsuen Wan District Council.

AMENDMENT OF FOURTH SCHEDULE

7. The Amendment Order at <u>Annex</u> amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to give effect to the changes set out in paragraphs 4, 5 and 6 above.
