Waterworks Ordinance (Cap. 102)

WATERWORKS (AMENDMENT) REGULATION 2019

INTRODUCTION

Section 29A of the Interpretation and General Clauses Ordinance (Cap. 1) empowers the Financial Secretary (which means also the Secretary for Financial Services and the Treasury by virtue of section 3 of Cap. 1) to vary fees which have previously been fixed by subsidiary legislation made by the Chief Executive in Council.

2. In exercise of this power, the Secretary for Financial Services and the Treasury has made the Waterworks (Amendment) Regulation 2019 ("the Regulation") to revise 25 items of fees and charges specified in the Waterworks Regulations (Cap. 102A) made pursuant to the Waterworks Ordinance (Cap. 102).

BACKGROUND AND JUSTIFICATIONS

- 3. In line with the "user pays" principle, it is Government's policy that fees and charges should in general be set at levels adequate to recover the full cost of providing the services. The 25 items of fees and charges concerned are prescribed in Schedule 1 to the Waterworks Regulations (Cap. 102A) under the Waterworks Ordinance (Cap. 102). The 25 items were last revised on 1 January 2015. They include
 - (a) fees for making a connection to the main and installing (including reinstatement of the ground surface) the part of a fire service or inside service on land held by the Government for pipes of any size up to and including 40 mm in diameter (6 items);
 - (b) fee for reconnecting a fire service or inside service (1 item);
 - (c) fee for providing and installing a meter (1 item);
 - (d) fee for providing a meter (1 item);

- (e) fee for resealing a fire service or meter (1 item);
- (f) fees for testing a meter or a private check meter (including removal and refixing) (4 items);
- (g) fees for plumber's licence issuance, renewal and examination (3 items);
- (h) fee for fishing licence issuance (1 item);
- (i) fees for examination of a water sample (5 items);
- (j) fee for attendance for collection of any sample or samples (1 item); and
- (k) fee for providing additional copy of examination report (1 item).
- 4. A review of the costs of providing the relevant services at the 2018-19 price level has been carried out recently. The result shows the cost recovery rates at existing fee levels for the 25 items range from 19.6% to 93.7%. In order to achieve full-cost recovery gradually and to avoid a steep fee increase, we propose to adopt the following guidelines for the fees and charges revision in our proposal for the 25 items
 - (a) for items with existing cost recovery rate of less than 40%, adopt an increase of about 20% or more; in particular, for items with existing cost recovery rate well under 40%, adopt a more aggressive percentage increase to achieve full-cost recovery within 5 to 7 years;
 - (b) for items with existing cost recovery rate of between 40% and 70%, adopt an increase of about 15%; and
 - (c) for items with existing cost recovery rate of over 70%, adopt an increase of about 10% or lower.
- 5. Details of the fees and charges revision proposal with upward adjustments ranging from 6.2% to 31.6% for the 25 items are provided in **Annex 1.** Should the proposed fees and charges revision be implemented, the cost recovery rates would be improved, ranging from 25.8% to 99.5%. The impact of the fees and charges revision on persons affected should not be significant.

THE REGULATION

6. The Regulation at **Annex 2** revises the fees and charges concerned. It is proposed that the new fees and charges will come into effect on 29 March 2019.

LEGAL IMPLICATIONS

7. The proposed amendments do not affect the current binding effect of the Waterworks Ordinance and the subsidiary legislation. They are in conformity with the Basic Law, including the provisions concerning human rights.

FINANCIAL AND CIVIL SERVICE IMPLICATIONS

8. Should the proposed fees and charges revision be implemented, the estimated increase in revenue would be about \$2.8 million per annum. There are no civil service implications.

ECONOMIC IMPLICATIONS

9. There are no significant economic implications.

EFFICIENCY INITIATIVES

10. The Government will continue to enhance efficiency and streamline procedures so as to contain the costs of providing these public services.

PUBLIC CONSULTATION

11. We consulted the Panel on Development of the Legislative Council on the proposal via an information paper issued on 15 October 2018 (reference: LC Paper No. CB(1)32/18-19(01)). Members noted the proposal and raised no objection at the Panel meeting on 23 October 2018.

PUBLICITY

12. The Regulation will be published in the Gazette on 25 January 2019 and a press release will be issued. A spokesman will be available to answer enquiries on the subject.
