1. Introduction

- 1.1 The Council adopted at its Legislative meeting 19 March 2014 the Policy on Access to the Legislature's Documents and Records ("the Policy") at Schedule 2 to the Rules of Procedure. Council also approved the establishment of the Committee on Access to Legislature's Documents and Records ("the Committee") to carry out the functions as set out in the new Rule 74A of the Rules of Procedure, including determining whether a document or record of the Legislature or its committee should be made available for access earlier than the expiry of the closure period; setting guidelines for implementing the Policy; considering any objection against the denial of access to such a document or record by the Clerk to the Legislative Council ("LegCo"); and considering any other matter relating to or arising from the Policy.
- 1.2 The Committee consists of the President, who shall be the chairman of the Committee, the chairman of the House Committee, who shall be the deputy chairman of the Committee, the deputy chairman of the House Committee and not more than 10 other members who shall be elected at a House Committee meeting in such manner as the House Committee may determine. The membership lists are in **Appendix I**.
- 1.3 This report covers the period from October 2016 to July 2020, during which one meeting was held. Members considered and deliberated:
 - (a) Consultation of the Law Reform Commission on Access to Information;
 - (b) Copying of archival documents and records;
 - (c) Consideration of access requests for closed documents and records of the Legislature; and
 - (d) Access review for time-expired documents and records.

2. Consultation of the Law Reform Commission on Access to Information

- 2.1 In response to the invitation of the Access to Information Sub-committee of the Law Reform Commission of Hong Kong ("LRC") to give views on the Consultation Paper on Access to Information ("the Consultation Document"), the President of LegCo has directed the Committee to consider various recommendations in the Consultation Document relating to LegCo.
- 2.2 The Committee has considered the recommendations set out in the Consultation Paper at the meeting on 18 March 2019. The Committee's response is set out in paragraphs 2.3 to 2.6 below.
- 2.3 The Committee notes that LRC recommends in the Consultation Document that the list of organizations covered under The Ombudsman Ordinance (Cap. 397) should be subject to the regime under the proposed The LegCo Secretariat is one of such access to information law. Among the various records and documents held by the organizations. LegCo Secretariat, LRC recommends that absolute exemption be granted to information relating to LegCo privilege (i.e. documents relating to legislative proceedings). The effect of this is that the LegCo Secretariat would not be under a duty to disclose to the public LegCo information that is subject to LegCo privilege under the access to information legislation after its enactment. If the LegCo Secretariat refuses to disclose the requested information, the aggrieved applicant could seek a review of the refusal by the Ombudsman.
- 2.4 The Committee considers that, given the unique nature of its documents and records, LegCo, in devising the Policy, has taken into account the legislative privilege that attaches to documents and records relating to LegCo proceedings. To implement the Policy, LegCo has drawn up various guidelines that best suits its operational needs. As the management of parliamentary information is part and parcel of the privilege of a Legislature to control or regulate its own affairs and given that LegCo already has a well-developed access to information policy, the Committee considers it more appropriate to exempt LegCo from the application of the proposed access to information legislation. That said, LegCo should continue to review and update its policy and guidelines on access to information to ensure adherence to best practices and international standards, and make reference to the provisions of the

access to information law if enacted in further improving its Policy.

- 2.5 The Committee also considers that the functions of The Legislative Council Commission ("the Commission") are closely related to the exercise of the powers and functions of LegCo. Given the relationship between LegCo and the Commission as provided in The Legislative Council Commission Ordinance (Cap. 443), the Committee considers that information of the Commission, similar to LegCo information, should also not be subject to the regime proposed in the access to information legislation.
- 2.6 In response to LRC's Consultation Paper on Archives Law, the Committee also notes that the Commission has also invited LRC to consider that it may not be necessary or appropriate to apply the public records management regime to LegCo records should an archives law be introduced.

3. Copying of archival documents and records

- 3.1 For archival documents and records which were produced by the Legislature in Hong Kong (including papers and minutes of meetings prepared by the LegCo Secretariat), members of the public are allowed to make copy at the fees and charges approved by the Commission. For preservation purpose, all copying should be carried out by Archives' staff of LegCo. The schedule of fees and charges for copying of archival documents and records is published onto the LegCo Website.
- 3.2 To avoid any possible infringement of the copyright subsisting in the documents and records owned by persons or entities other than the Legislature, members of the public may only inspect but not make copies of such documents and records. These documents and records mainly include papers provided by the Administration, correspondences between the LegCo Secretariat and the Administration, press cuttings, and submissions or publications of deputations, etc.
- 3.3 In order to strike a better balance between enhancing operation transparency of LegCo and respecting the copyright of the documents and records in the Archives that are not originally produced by the Legislature, the Committee decided at its meeting on 18 March 2019 that the copying of open archival documents and records owned or produced

by persons and entities other than the Legislature should be allowed, and members of the public concerned should be requested to sign an indemnity if they request to make copies. The current arrangement for LegCo Archives' staff to undertake the actual copying of archival documents and records will be maintained to ensure proper handling of these documents and records.

4. Consideration of access requests for documents and records of the Legislature

- 4.1 In handling an access request, the LegCo Secretariat follows the practice and procedure to conduct a review to determine whether such documents or records fall within any of the exempted categories. For confidential documents or records, the Committee's approval will be sought on whether the access should be granted or granted with conditions. The Committee's approval is also required for access to closed documents and records prior to the expiry of their closure period. Under the delegated authority, the Clerk to LegCo may also approve access requests for closed documents or records the closure period of which has expired. To enhance transparency, the Committee has published the updated lists of approved and denied access requests onto the LegCo Website.
- 4.2 A total of 68 access requests were approved during the period covered by this report. Details of these access requests are in **Appendix II**.

5. Access review for time-expired documents and records

- 5.1 According to Rule 6(5A)(a) of the Rules of Procedure, the Clerk to LegCo shall conduct review on the Legislature's documents and records within 25 years of their existence and decide whether they should be disclosed for public inspection.
- 5.2 During the period covered by this report, the Clerk to LegCo has conducted reviews and approved 146 sets of unclassified files under his delegated authority. Details of these files (**Appendix III**) have also been uploaded onto the LegCo Website.
