Proposed resolutions to amend the Pilotage Ordinance (Amendment of Schedule 2) Notice 2019 ("the Notice") and the Pilotage (Dues) (Amendment) Order 2019 ("the Order") **Debate and voting arrangements**

Object of the Notice: To amend Schedule 2 to the Pilotage Ordinance (Cap. 84) to

specify three areas of water in Mirs Bay as pilot boarding stations, and make technical amendments to that Schedule so that co-ordinates based on the World Geodetic System 1984

(WSG 84) are adopted.

Object of the Order To amend the Schedule to the Pilotage (Dues) Order (Cap. 84) sub. leg. D) to provide for:

(a) additional pilotage dues for requiring a pilot to board, or

disembark from, a ship in Mirs Bay; (b) an additional pilotage due for boarding, or disembarking

from, a ship in Mirs Bay on notice of less than five hours:

(c) a pilotage due for cancelling the engagement of a pilot within three hours before the last stated time of a requirement for pilotage services in Mirs Bay;

(d) an additional pilotage due for altering the engagement of

(i) within three to five hours before the last stated time of a requirement for pilotage services in Mirs Bay; and

(ii) within one to three hours before the last stated time of a requirement for pilotage services elsewhere; and

to make other minor textual amendments.

Joint debate

Joint debate on Hon Frankie YICK's batch of proposed resolutions (two in total) which seek to amend the above two items of subsidiary legislation.

Those proposed resolutions seek to defer the **commencement date** of implementation of pilotage services at three areas of water in Mirs Bay. Details are as follows:
