Continuation of the discussion on FCR(2019-20)46

The Finance Committee ("FC") continued with the discussion on item FCR(2019-20)46 on the Anti-epidemic Fund ("the Fund"). The Chairman thanked the Administration for attending, and the Legislative Council Secretariat for arranging this meeting which had been called at very short notice.

Scope and implementation of the Anti-epidemic Fund

2. Noting members' earlier comments on the limited scope of the Fund, Mr IP Kin-yuen and Mr WU Chi-wai suggested that:

- (a) apart from direct subsidies, other measures such as persuading banks to provide interest-free loans should be considered;
- (b) support should be extended to part-time teachers and arts/sports instructors at schools, as well as those who lost their jobs or suffered wage cut as a result of the epidemic; and
- (c) a subsidy should be provided to all establishments which could furnish proof (e.g. mandatory provident fund contributions records) that they were in operation and employing staff.

3. Given that many sectors/individuals not covered by the Fund were also hard hit by the epidemic, Mr SHIU Ka-chun, Mr LEUNG Yiu-chung and Dr Fernando CHEUNG considered that:

- (a) the Administration should take on board a suggestion from the Hong Kong Council of Social Service to set up an emergency support fund to provide each non-government organization providing social services a subsidy of

\$200,000;

- (b) the second round of relief measures should be introduced as soon as practicable;
- (c) the plight of employees was not addressed as most of the subsidy schemes would benefit employers only; and
- (d) many disadvantaged individuals could not benefit from the Fund as its main target was businesses.

4. While concurring that other needy sectors should be identified for the next round of relief measures, Ms Starry LEE and Dr Priscilla LEUNG expressed the following views:

- (a) consideration might be given to using any unspent balance of the Fund to provide support to other affected sectors based on their proven needs; and
- (b) proper discretion should be exercised when administering the Fund in order that effective assistance could be provided.

5. In response to members' concerns, Chief Secretary for Administration ("CS") reiterated the Administration's stance that:

- (a) top priority was accorded to the 24 initiatives proposed under the Fund to provide timely relief to hard hit sectors;
- (b) as the fight against the epidemic continued, the Administration might identify further relief measures and other sectors/individuals in need of financial support; and
- (c) the Administration would welcome views and suggestions on the scope and implementation of the Fund.

6. In response to concerns raised by Dr Helena WONG and Dr Fernando CHEUNG about support for social enterprises, CS said that:

- (a) depending on their nature (e.g. retail business), some flexibility would be exercised, such as by waiving the requirement for business registration, to enable social enterprises to benefit from relevant subsidy scheme(s); and

- (b) these enterprises might also benefit from further support measures which might be introduced by the Administration in light of actual needs.

7. Mr KWONG Chun-yu enquired about the support, if any, available to the film industry during this difficult period. Secretary for Commerce and Economic Development ("SCED") recapitulated that in mid 2019, the Government had made a further injection of \$1 billion into the Film Development Fund to help foster the development of the film industry.

8. Mr Jeremy TAM considered that apart from relief measures of the Airport Authority ("AA"), more direct support should be provided to the airline industry and the related employees. Secretary for Transport and Housing ("STH") confirmed that the Administration would maintain close communication with the industry on how best to help them tide over the hard times.

9. Mr KWOK Wai-keung and Mr Steven HO considered that the Fund should be supported notwithstanding its limited scope, and stressed that:

- (a) business establishments in receipt of subsidies should make every effort not to lay off their staff; and
- (b) the Administration should proactively seek to identify other affected sectors in need of assistance, such as recreational fishing on mariculture rafts.

10. In anticipation of a deteriorating economy, Ms Claudia MO was concerned whether additional injection to the Fund would be required. CS said that the Administration would not preclude the implementation of further support measures if circumstances so required.

11. Mr HO Kai-ming expressed concerns about the protection for employees during and after the epidemic. CS said that the Government looked forward to the joint efforts from employers and employees to ride out the current crisis and bring about a re-boot of the economy to benefit all sectors.

12. In reply to Mr WU Chi-wai's enquiry about the entry of Mainland residents to Hong Kong, CS clarified that the Mainland authorities had ceased to issue "Endorsements" for business visits, group visits and individual visits.

13. In reply to Dr Pierre CHAN's enquiry about the administrative costs for early implementation of the relief measures, CS said that:

- (a) if existing data/systems were available, processing work would be absorbed by existing manpower;
- (b) where the number and eligibility of beneficiaries had to be ascertained, the Administration would work closely with other organizations such as the Trade Development Council, and make use of the Internet as far as practicable to save manpower resources; and
- (c) while the timing for disbursement of subsidies varied among schemes, it was expected that eligible recipients would be able to receive the subsidies in three to four months.

Dissemination of epidemic-related information

14. Dr Pierre CHAN thanked the Centre for Health Protection ("CHP") for their hard work during this period. Dr CHAN and Mr CHU Hoi-dick requested that the following information be uploaded onto the thematic webpage of CHP:

- (a) an archive on past daily information on the situation on cases of COVID-19, instead of publishing only the latest daily situation report; and
- (b) daily updates on the number of compulsory quarantine orders issued at various border control points since 8 February 2020.

15. Secretary for Food and Health ("SFH") agreed to relay their suggestions to CHP.

Supply of masks

16. On the global procurement of personal protective equipment including masks, Mr CHAN Chi-chuen asked whether the Administration would collaborate with the 18 District Councils to distribute surplus masks to those in need. CS said that subject to sufficient stock and having satisfied the priority needs of healthcare and frontline staff, the Administration would be pleased to share any surplus with members of the public in need of such masks.



Retail Sector Subsidy Scheme

17. Mr SHIU Ka-fai said that the Alliance of Retailers (零售大聯盟) had been negotiating with landlords/property developers on possible rental reduction. He urged for early disbursement of subsidy under the Scheme as the sector was now in direstraits. In response, CS advised that:

- (a) with the experience and expertise of the Trade Development Council as the implementation agent, the requisite computer systems would be set up and invitation for applications would commence shortly; and
- (b) every effort would be made to expedite the process and it was expected that the subsidy could be disbursed in three to four months.

Arts and Culture Sector Subsidy Scheme

18. Mr CHAN Chi-chuen suggested that individual schools should continue to pay arts/sports instructors for providing coaching via the Internet, as provision might already have been earmarked for their services. He also enquired whether performing groups would be subsidized for cancellation of performances, similar to the case of Cantonese operas.

19. Mr MA Fung-kwok enquired whether assistance would be provided to the following parties currently outside the purview of the Scheme:

- (a) concert organizers which had incurred heavy losses as a result of cancellations;
- (b) arts and sports instructors providing coaching or training in schools;
- (c) privately run entities such as music companies, arts/dance studios; and
- (d) the sports sector.

20. In response, Secretary for Home Affairs ("SHA") and Secretary for Education ("SED") advised that:

- (a) on this occasion, priority had been given to supporting formal education provided by schools and arts/culture groups affected by the closure of mainly government

facilities;

- (b) as the mode of service provided by arts/sports instructors varied among schools, the Administration would consider feasible ways to render support; and
- (c) the Administration would consider how best to address the needs of arts- and sports-related parties not covered under the Fund.

Ex-gratia payment to households of two public housing estates designated as quarantine centres

21. Given the high rent of private flats including subdivided flats and the long waiting period for allocation of units, Mr LAM Cheuk-ting and Mr Alvin YEUNG opined that the ex-gratia allowance of \$6,000 for each affected household was grossly inadequate and should be increased. In response, STH explained that:

- (a) when the Housing Authority ("HA") offered the public housing units concerned to the applicants, the latter were specifically advised that the intake date could not yet be confirmed;
- (b) special arrangements were now made for affected prospective tenants. They could choose to wait till their allocated units were ready for intake, or choose to be allocated to other estates;
- (c) those with immediate housing difficulty could approach HA for interim housing; and
- (d) after the Chun Yeung Estate had ceased to be used as a quarantine centre, HA would arrange to complete the necessary reinstatement works expeditiously.

Food Licence Holders Subsidy Scheme

22. In reply to Dr Helena WONG's enquiry on whether cooked food stalls operating in markets of the Food and Environmental Hygiene Department ("FEHD") could benefit from the Scheme, Director of Food and Environmental Hygiene advised that:

- (a) the Scheme would only apply to holders of eight types of food licences;
- (b) since October 2019, cooked food stalls in FEHD markets had benefited from a six-month 50% rental reduction, which was part of a package of relief measures announced by the Financial Secretary ("FS"); and
- (c) whether the rental reduction would be extended beyond 31 March 2020 would be announced by FS in the upcoming Budget.

Support for the transport and airport-sectors

23. Mr Frankie YICK said that the Government should consider providing guarantee to facilitate enterprises in obtaining loans. Pointing out that many small and medium operators of the transport sector were unable to obtain any principal moratorium from their banks/lending institutions, Mr YICK urged the Hong Kong Monetary Authority ("HKMA") to encourage the banking sector to provide such a facility to ease the liquidity crunch. While highlighting that it would be for individual banks to make their commercial decisions, Secretary for Financial Services and the Treasury agreed to relay Mr YICK's views to HKMA.

Home quarantine support

24. Mr Alvin YEUNG sought confirmation on the following:

- (a) whether the use of electronic wristbands would never be expanded to enable disciplined services such as the Police to carry out surveillance on individuals; and
- (b) details of the participants from the Government, industry, academic and research sectors which owned the patent of the product in question.

25. In response, Secretary for Innovation and Technology ("S for IT") advised that:

- (a) the sole purpose of developing the electronic wristbands was to enhance the Government's capability in combating the epidemic;

- (b) the products were developed with collaborative efforts of the Government, industry, academic and research sectors; and
- (c) the Government had no plan to use the wristbands for other purposes such as surveillance.

26. Mr Alvin YEUNG said that he might write to S for IT to seek further details of the participants which collaborated in the development of the wristbands.

Support to child care centres

27. Mr LEUNG Che-cheung enquired whether:

- (a) the special cash grant for child care centres would be extended beyond the four-month period (February to May 2020); and
- (b) financial support would be provided to parents who enrolled their children at these centres.

28. In reply, Secretary for Labour and Welfare said that the Administration would consider further support measures in the light of prevailing circumstances.

Rental burden

29. Referring to the exorbitant rental for shops in the airport, Mr Frankie YICK questioned the efficacy of the relief measures totaling \$1.6 billion introduced by AA, and considered that:

- (a) the said amount included the income foregone as a result of deferred increase in rental and fees/charges; and
- (b) as business was very poor, the reduction in percentage rent but not basic rent could hardly relieve the tenants' hardship.

30. STH responded that as understood by the Administration, AA had been working very closely with its business partners in aviation, logistics and retail during the past half year or so to cope with the impact arising from social unrests and the epidemic.

31. Ms Starry LEE enquired about past efforts and plans, if any, of the Administration to lobby or incentivise major landlords to reduce rent, thereby easing the financial burden on business operators. SCED said that while the Administration had taken the lead to reduce rent at government properties, it had also met with major property developers/landlords to appeal for more support for their tenants.

32. Noting that almost all sectors were under an exceptionally heavy rental burden, Mr Michael TIEN urged the Administration to seriously consider his suggestion to provide tax credit rebate to landlords as an incentive for reducing rent up to 50%. CS took note of his suggestion for consideration.

One-off cash payout

33. Ms Alice MAK and Mr Michael TIEN indicated support for making a cash payout of \$10,000 to all to benefit the entire community. Mr TIEN further suggested that the Administration might double the amount to \$20,000 for donation to charities should an eligible resident decide to give up his/her right to receive the cash payout. CS took note of Mr TIEN's suggestion for consideration.

34. Ms Claudia MO, Mr IP Kin-yuen, Dr Fernando CHEUNG and Mr CHU Hoi-dick expressed the following views:

- (a) both the proposed cash payout and the Fund were publicly-funded initiatives aimed at easing the adverse impact of the epidemic on the community;
- (b) it was in order for the Fund to disburse a one-off subsidy to all residents, given that one of its objectives was to provide assistance or relief to enterprises and members of the public; and
- (c) the cash payout should have been included under the Fund for early approval by FC, instead of in the upcoming Budget.

35. In response, CS pointed out that the two initiatives should be considered independently of each other as the Fund aimed at providing urgent support to those sectors hard hit by the epidemic, while the proposed cash payout was meant for general coverage.

Assistance to Hong Kong residents outside Hong Kong

36. Mr Steven HO raised the following concerns on behalf of Mr Vincent CHENG who was currently in Japan:

- (a) special financial provision should be earmarked for assisting Hong Kong residents who ran into difficulties when outside Hong Kong; and
- (b) consideration should be given to swiftly despatching a special taskforce to assist these people.

37. Dr Helena WONG suggested that the Administration should follow up with the cruise company of Princess Diamond on the compensation payable to Hong Kong passengers, and enquired about the arrangements for close contacts of the infected persons who had tested negative for the virus.

38. In response, CS and SFH advised that:

- (a) a mechanism was in place under which the Economic and Trade Offices ("ETOs"), in collaboration with the relevant Chinese embassy or Mainland authorities, would provide all practicable assistance to stranded Hong Kong residents; and
- (b) where land quarantine facilities were not available and if the close contacts of the infected persons on board Princess Diamond were fit to travel, arrangements would be made to facilitate their early return to Hong Kong.

39. Ms Alice MAK noted that many local residents had been residing in the Mainland due to high property prices in Hong Kong. Upon implementation of the compulsory 14-day home quarantine order, they had returned to stay in Hong Kong so as to safeguard their jobs. Ms MAK said that the Administration should support them by providing short-term accommodation or a special allowance.

40. While expressing support for the Fund and its early implementation, Dr Priscilla LEUNG reiterated her earlier request for prompt assistance to Hong Kong residents stranded in Hubei Province. Dr Helena WONG expressed concern that ETO (Wuhan) did not have sufficient manpower to handle the large number of cases.

Motions proposed by members under paragraph 37A of the Finance Committee Procedure

41. Mr Abraham SHEK declared interest in respect of his role in a number of listed companies and non-profit making bodies. Mr LEUNG Yiu-chung declared that the organization to which he belonged was a training body under the Employees Retraining Board.

42. At 8:43 pm, FC started to vote on whether the motions proposed by members under paragraph 37A of the Finance Committee Procedure ("FCP 37A motions") should be proceeded with. The Chairman put to vote the questions, one by one, that these FCP 37A motions should be proceeded with forthwith. At the request of members, the Chairman ordered a division on each question. Immediately after the Chairman announced that FC decided against proceeding with the first FCP 37A motion proposed by Mr Alvin YEUNG, Mr CHAN Hak-kan moved without notice a motion under paragraph 47 of the Finance Committee Procedure that in the event of further divisions being claimed in respect of any motions or questions under the same agenda item, FC should proceed to each of such divisions immediately after the division bell had been rung for one minute. The Chairman declared that the motion was carried.
