Examples of past cases in which Rule 80 of the Rules of Procedure was invoked to exercise summoning powers

Section 9 of the Legislative Council (Powers and Privileges) Ordinance (Cap. 382) empowers the Legislative Council ("LegCo") or a standing committee thereof 1 or any other committee which is specially authorized by a resolution of LegCo to order any person to attend before LegCo or before such committee and to give evidence or to produce any paper, book, record or document in the possession or under the control of such person ("summoning powers"). Rule 80 of the Rules of Procedure ("RoP") reflects section 9 of Cap. 382.

2. At the meeting of the Finance Committee ("FC") held on 13 December 2019, a member proposed under RoP 80 and paragraph 19 of the Finance Committee Procedure ("FCP") to summon certain Government official(s) to attend relevant FC meeting(s) to testify and give evidence in relation to agenda item FCR(2019-20)33 concerning 2019-2020 civil service pay adjustment. Members noted at the meeting that the existing RoP and FCP did not provide for a procedure under which FC might determine the exercise of such powers or otherwise. In this connection, some members enquired about the relevant procedures and practices in accordance with which relevant LegCo committees had determined the exercise of summoning powers or otherwise in the past.

The standing committees are the Committee on Members' Interests, the Finance Committee and the Public Accounts Committee.

- 3. Regarding standing committees, according to the records kept by the LegCo Secretariat, both FC and the Committee on Members' Interests have never exercised summoning powers. The Public Accounts Committee ("PAC") exercised such powers on two occasions. Given that PAC, as a standing committee, may determine whether or not such powers should be exercised without having to seek authorization from LegCo, PAC will, as a general practice, discuss and determine the exercise of such powers at closed meetings, if necessary.² The relevant PAC reports only briefly recorded the proceedings of making the decisions concerned. Members may refer to the PAC reports listed in the **Appendix**.
- 4. Regarding committees other than standing committees, in general, the exercise of such summoning powers will be discussed by such committees prior to seeking LegCo's authorization. If the committees approve the relevant recommendations, they will then seek support from the House Committee ("HC"). If the recommendations are supported by HC, either the HC Chairman or the Chairmen of the relevant committees will move the motions concerned at LegCo meetings to seek LegCo's approval for such authorization. The relevant motions will be handled under the procedure as laid down in RoP.
- 5. A list of examples of past cases in which summoning powers were exercised by LegCo committees is in the **Appendix**.
