#### Action

<u>Ir Dr LO Wai-kwok</u>, the Chairman of the Public Works Subcommittee ("the Subcommittee") in office, presided over the election of the Chairman of the Subcommittee for the 2019-2020 session.

#### **Election of Chairman**

- 2. <u>Ir Dr LO Wai-kwok</u> invited nominations for the chairmanship of the Subcommittee.
- 3. Ir Dr LO Wai-kwok was nominated by Mr Frankie YICK and the nomination was seconded by Mr CHAN Hak-kan. Ir Dr LO Wai-kwok accepted the nomination.
- 4. As Ir Dr LO Wai-kwok was nominated for the chairmanship, Mr Charles Peter MOK, the Deputy Chairman of the Subcommittee in office, presided over the election of the Chairman. Mr MOK asked members if there were other nominations.
- 5. Mr HUI Chi-fung was nominated by Mr Gary FAN and the nomination was seconded by Ms Tanya CHAN. Mr HUI Chi-fung accepted the nomination.

- 6. Mr Alvin YEUNG was nominated by Mr CHU Hoi-dick and the nomination was seconded by Ms Tanya CHAN. Mr Alvin YEUNG accepted the nomination.
- 7. Mr Jeremy TAM was nominated by Mr HUI Chi-fung and the nomination was seconded by Ms Tanya CHAN. Mr Jeremy TAM accepted the nomination.
- 8. Dr CHENG Chung-tai was nominated by Mr Gary FAN and the nomination was seconded by Ms Tanya CHAN. Dr CHENG Chung-tai accepted the nomination.
- 9. <u>Mr Alvin YEUNG</u> nominated Dr Fernando CHEUNG who was absent and stated that Dr Fernando CHEUNG's acceptance of the nomination had been secured. The nomination was seconded by <u>Ms Tanya CHAN</u>.
- 10. <u>Mr HUI Chi-fung</u> nominated Mr WU Chi-wai who was absent and stated that Mr WU Chi-wai's acceptance of the nomination had been secured. The nomination was seconded by <u>Ms Tanya CHAN</u>.
- 11. <u>Mr HUI Chi-fung</u> nominated Mr KWONG Chun-yu who was absent and stated that Mr KWONG Chun-yu's acceptance of the nomination had been secured. The nomination was seconded by Ms Tanya CHAN.
- 12. Mr CHU Hoi-dick was nominated by Mr Alvin YEUNG and the nomination was seconded by Ms Tanya CHAN. Mr CHU Hoi-dick accepted the nomination.
- 13. <u>Mr Gary FAN</u> nominated Mr AU Nok-hin who was absent and stated that Mr AU Nok-hin's acceptance of the nomination had been secured. The nomination was seconded by <u>Ms Tanya CHAN</u>.
- 14. <u>Mr Alvin YEUNG</u> nominated Ms Claudia MO who was absent and stated that Ms Claudia MO's acceptance of the nomination had been secured. The nomination was seconded by <u>Ms Tanya CHAN</u>.
- 15. There being no other nomination, <u>Mr Charles Peter MOK</u> declared that there were a total of 11 valid nominations and announced a vote by secret ballot. After members present had cast their votes, <u>Mr MOK</u> invited the nominators to monitor the counting of votes, and Mr Frankie YICK and Mr Gary FAN then came in front of the Chairman's podium to monitor the counting of votes. Of the members present, 28 voted for Ir Dr LO Wai-kwok, eight voted for Mr CHU Hoi-dick and no member voted

for the other nine nominees. <u>Mr MOK</u> declared that Ir Dr LO Wai-kwok was elected Chairman of the Subcommittee for the 2019-2020 session. Ir Dr LO Wai-kwok took over the chair in his capacity as the Chairman.

# **Election of Deputy Chairman**

- 16. <u>The Chairman</u> invited nominations for the deputy chairmanship of the Subcommittee.
- 17. Mr CHU Hoi-dick was nominated by Mr CHAN Chi-chuen and the nomination was seconded by Mr Charles Peter MOK. Mr CHU Hoi-dick accepted the nomination.
- 18. Mr Steven HO was nominated by Mr WONG Ting-kwong and the nomination was seconded by Mr Martin LIAO. Mr Steven HO accepted the nomination.
- 19. Mr Charles Peter MOK was nominated by Mr Martin LIAO and Mr CHAN Chi-chuen respectively and the nomination was seconded by Mr Abraham **SHEK** and Ms Elizabeth **OUAT** respectively. Mr Charles Peter MOK eventually nomination accepted the by Mr Martin LIAO.
- 20. There being no other nomination, the Chairman declared that there were a total of three valid nominations and announced a vote by secret ballot. After members present had cast their votes, the Chairman invited the nominators to monitor the counting of votes, and Mr CHAN Chi-chuen and Mr WONG Ting-kwong then came in front of the Chairman's podium to monitor the counting of votes. Of the members present, 11 voted for Mr CHU Hoi-dick, seven voted for Mr Steven HO and 26 voted for Mr Charles Peter MOK. The Chairman declared that Mr Charles Peter MOK was elected Deputy Chairman of the Subcommittee for the 2019-2020 session.
