Concerning Subhead A007GX under Head 710, I would like to know the detailed scope of works in respect of the "Electronic Training Materials Storage System for Hong Kong Police College", "e-Solution to Promotion to Sergeant Qualifying Examination", "Digital Video Editing System (Police College)", "IT Facilities for Police Operational Base and Reporting Centre in Liantang/Heung Yuen Wai Boundary Control Point", and "Network System for New Kowloon East Regional Headquarters Complex and Ngau Tau Kok Police Services Centre".

The detailed scope of works in respect of the 5 projects is as follows:

It was repeatedly reported that arrestees had been sexually abused by the Police. Will the projects provide protection for arrestees against sexual violence? If yes, please provide details, and if no, please provide justifications.

Moreover, the Police review their detention facilities from time to time. As far as Subhead 3101GX under Head 703 is concerned, the main purpose of the project is to enhance the security and safety of the detention facilities concerned.

Concerning Subhead 3101GX under Head 703, I would like to know the detailed scope of works in respect of 4 projects, namely "Improvement works of dog kennel in Happy Valley Police Station", "Improvement works of dog kennel in Tai Po Police Station", "Improvement works of dog kennel in Tsuen Wan Police Station" and "Improvement works of dog kennel in Tuen Mun Police Station". As police dogs may inhale tear gas in the course of duty, will the relevant facilities include provision of treatment for police dogs suffering from tear gas inhalation or equipment specially for cleaning up tear gas residue on police dogs? If yes, please provide details, and if no, please provide justifications.

According to the Police record, since June 2019, no reports of police dogs falling sick after performing their duties have been received from handlers. Police dog handlers are very concerned about the physical well-being of police dogs and will arrange immediate medical examination and treatment


should any Police dog is found feeling unwell. The Police have been maintaining close contact with the Agriculture, Fisheries and Conservation Department and the professional veterinary team to ensure the physical wellbeing of police dogs.

5. Concerning Subhead 7100CX under Head 707, I would like to know the detailed scope of works and layout plan in respect of "Site Formation and Infrastructure Works for Police Facilities in Kong Nga Po – detailed design and site investigation".

The scope of the project mainly covers:

- site formation of about 19 hectares of land for accommodating various police facilities to be co-located at Kong Nga Po;
- upgrading of existing Kong Nga Po Road of about 1.7 kilometres long to a 7.3 metres wide single two-lane carriageway and construction of a new vehicular bridge of about 100 metres long; and
- associated infrastructure works, including road works, waterworks, drainage and sewerage works, geotechnical works, landscaping works, works relating to environmental mitigation measures, and other ancillary works.

The layout plan of the site formation and infrastructure works is attached for reference. For details, please refer to the discussion paper for the Public Works Subcommittee of the Finance Committee (PWSC(2018-19)41) (see Appendix 1).
