HC formed a subcommittee to study items (1) to (7) in detail at the special HC meeting held on 8 May 2020 at 2:30 pm, and agreed that item (19) should be studied by the same subcommittee at the HC meeting on 29 May 2020. The Subcommittee made a verbal report on items (6) and (7) at the HC meeting on 29 May 2020, and provided Members with a written report on these two items vide LC Paper No. CB(2)1129/19-20 on 3 June 2020. In addition,

the Subcommittee made a verbal report on items (1) to (5) and item (19) at the HC meeting on 5 June 2020, and provided Members with a written report on these six items vide LC Paper No. CB(2)1173/19-20 on 10 June 2020.

- 4. A subcommittee was proposed to be formed to study item (15) in detail at the HC meeting on 29 May 2020. Since only one Member has signified to join the proposed subcommittee by the deadline for signification of membership, it cannot be formed by virtue of House Rules 21(b) and 26(f).
- 5. In respect of items (8) to (14) and items (16) to (18), HC considered it not necessary to form any subcommittee to study these 10 items of subsidiary legislation.
