Report No. 1/19-20 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 27 May 2020.

Subsidiary legislation considered

2. The House Committee has considered the following items of subsidiary legislation:

3. A subcommittee was proposed to be formed to study item (2) in detail at the special House Committee meeting held on 8 May 2020 at 2:30 pm. Since only one Member has signified to join the proposed subcommittee by the deadline for signification of membership, it cannot be formed by virtue of House Rules 21(b) and 26(f).

4. A subcommittee was proposed to be formed to study item (3) in detail at the special House Committee meeting held on 8 May 2020 at 2:30 pm. Since only two Members have signified to join the proposed subcommittee by the deadline for signification of membership, it cannot be formed by virtue of House Rules 21(b) and 26(f).

5. In respect of item (1), the House Committee considered it not necessary to form a subcommittee to study this item of subsidiary legislation.

Note: The House Committee formed a subcommittee to study the following seven items of subsidiary legislation at the special House Committee meeting held on 8 May 2020 at 2:30 pm. The Council passed at its meeting of 20 May 2020 a resolution moved by Hon CHAN Hoi-yan, Chairman of the Subcommittee, to extend the period for amending these seven items of subsidiary legislation to the Council meeting of 17 June 2020.
