- 3. HC formed four subcommittees to study item (1), items (2) to (4), items (5) to (9), as well as items (10) and (11) respectively in detail at the special HC meeting held on 8 May 2020 at 2:30 pm. The fourth Subcommittee reported its deliberations at the HC meeting on 29 May 2020 vide LC Paper No. CB(4)631/19-20. The first, second and third Subcommittees made verbal reports at the HC meeting on the same day respectively. The third Subcommittee provided Members with a written report vide LC Paper No. CB(4)661/19-20 on 2 June 2020. The first and second Subcommittees provided Members with written reports vide LC Paper Nos. CB(2)1126/19-20 and CB(2)1129/19-20 respectively on 3 June 2020.
- 4. In respect of items (12) to (17), HC considered it not necessary to form any subcommittee to study these six items of subsidiary legislation.

Note: HC formed a subcommittee to study the following two items of subsidiary legislation at its meeting on 29 May 2020.
