Action

I. Election of Chairman

Ms CHAN Hoi-yan was elected Chairman of the Subcommittee.

2. Members agreed that there was no need to elect a Deputy Chairman.

II. Any other business

Extension of scrutiny period

3. Members agreed that the Chairman would give notice to move three proposed resolutions at the Council meeting of 20 May 2020 to extend the scrutiny periods of the following 11 items of subsidiary legislation, so as to allow more time for the Subcommittee to study them:

- (a) Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (L.N. 31 of 2020);
- (b) Prevention and Control of Disease (Prohibition on Group Gathering) Regulation (L.N. 32 of 2020);
- (c) Prevention and Control of Disease (Requirements and Directions) (Business and Premises) (Amendment) Regulation (L.N. 33 of 2020);
- (d) Prevention and Control of Disease Ordinance (Amendment of Schedules 1 and 2) Notice 2020 (L.N. 46 of 2020);
- (e) Prevention and Control of Disease (Amendment) (No. 2) Regulation 2020 (L.N. 47 of 2020);
- (f) Compulsory Quarantine of Certain Persons Arriving at Hong Kong (Amendment) (No. 2) Regulation 2020 (L.N. 48 of 2020);

Action

- (g) Prevention and Control of Disease (Disclosure of Information) (Amendment) Regulation 2020 (L.N. 49 of 2020);
- (h) Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places (Amendment) Regulation 2020 (L.N. 50 of 2020);
- (i) Prevention and Control of Disease (Requirements and Directions) (Business and Premises) (Amendment) (No. 2) Regulation 2020 (L.N. 51 of 2020);
- (j) Prevention and Control of Disease (Prohibition on Group Gathering) (Amendment) Regulation 2020 (L.N. 52 of 2020); and
- (k) Prevention and Control of Disease (Prohibition on Group Gathering) (Amendment) (No. 2) Regulation 2020 (L.N. 59 of 2020).

Members noted that if the proposed resolutions were passed at the said Council meeting, the periods for amending L.N. 31 to L.N. 33 of 2020, L.N. 46 to L.N. 52 of 2020 and L.N. 59 of 2020 would be extended to the Council meetings of 10 June, 17 June and 24 June 2020 respectively.

Invitation of public views

4. Members agreed that the Subcommittee should receive written submissions from the public on the 11 items of subsidiary legislation under study. In line with usual practice, a general notice would be posted on the Legislative Council website and invitation letters would be issued to the 18 District Councils to invite views on these items of subsidiary legislation.

5. Members initially agreed that the second meeting of the Subcommittee could be held on 22 May 2020 at 10:45 am for discussion of the 11 items of subsidiary legislation with the Administration.

(Post-meeting note: Members were informed vide LC Paper No. CB(2)1003/19-20 issued on 15 May 2020 that with the concurrence of the Chairman, the second and third meetings of the Subcommittee would be held on 25 and 26 May 2020 respectively from 5:30 pm to 7:30 pm.)
