Action

I. Election of Chairman and Deputy Chairman

Election of Chairman

<u>Dr Priscilla LEUNG</u>, the incumbent Chairman, presided over the election and called for nominations for the chairmanship of the Panel on Administration of Justice and Legal Services ("the AJLS Panel") for the 2019-2020 session.

2. Dr Priscilla LEUNG was nominated by <u>Mr LAM Cheuk-ting</u> and the nomination was seconded by <u>Ir Dr LO Wai-kwok</u>. <u>Dr LEUNG</u> accepted the nomination. As Dr LEUNG was nominated, <u>Mr Dennis KWOK</u>, the incumbent Deputy Chairman, presided over the election of the chairmanship of the AJLS Panel, and called for other nominations.

3. Mr Alvin YEUNG was nominated by <u>Mr AU Nok-hin</u> and the nomination was seconded by <u>Ms Tanya CHAN</u>. <u>Mr YEUNG</u> accepted the nomination.

4. Mr CHAN Chi-chuen was nominated by <u>Ms Claudia MO</u> and the nomination was seconded by <u>Ms Tanya CHAN</u>. <u>Mr CHAN</u> accepted the nomination.

5. <u>Mr CHAN Chi-chuen</u> said that he accepted the nomination because he considered it unacceptable that Dr Priscilla LEUNG, the Chairman of the AJLS Panel for the 2018-2019 session, had refused members' request to conduct a public hearing to receive views from members of the public on the Fugitive Offenders and Mutual Legal Assistance in Criminal Matters Legislation (Amendment) Bill 2019. <u>Dr LEUNG</u> requested Mr CHAN to clarify by providing details on his allegations concerned.

6. <u>Mr Dennis KWOK</u> requested the Clerk to collate relevant information relating to the matters under dispute between Mr CHAN Chi-chuen and Dr Priscilla LEUNG for members' reference at the next meeting. <u>Ms Claudia</u> <u>MO</u> indicated support as it would facilitate members to better understand the matters in question.

7. <u>Mr SHIU Ka-chun</u> considered it inappropriate for the Legislative Council Secretariat to search for information to facilitate members nominated for chairmanship to challenge one another. <u>Mr James TO</u> also said that any disputes between members nominated for chairmanship during election should more appropriately be dealt with at a forum to present their platforms and answer members' questions, and it was inappropriate for the Legislative Council Secretariat to seek out information to facilitate either side in presenting his/her case. <u>Members</u> agreed.

8. <u>Mr Dennis KWOK</u> said that, owing to the arrival of end time for that meeting, the election of the Chairman would be suspended and be continued at the next meeting. <u>Members</u> noted that three valid nominations for chairmanship, namely Dr Priscilla LEUNG, Mr Alvin YEUNG and Mr CHAN Chi-chuen, had been received at the meeting and the call for nominations for the chairmanship had not yet closed.
