Action

I. Election of Chairman and Deputy Chairman

<u>Mr James TO</u> presided over the meeting. <u>Mr TO</u> explained to members that since Mr Dennis KWOK, the Deputy Chairman of the Panel on Administration of Justice and Legal Services ("the Panel") for the 2018-2019 session who presided over the election of Chairman of the Panel for the 2019-2020 session at the previous two meetings, was absent from the present meeting, he would preside over the election in accordance with paragraph 2(b) in Appendix IV to the House Rules as the member present having the highest precedence among the members not nominated for the office of the Chairman.

2. <u>Mr James TO</u> recapitulated that when the last Panel meeting held on 28 October 2019 was adjourned, a total number of 11 nominations for the chairmanship of the Panel had been validly made. Since then, Mr CHU Hoi-dick was elected Deputy Chairman of the Panel on Manpower at its meeting on 29 October 2019 and, according to Rule 77(7) of the Rules of Procedure, Mr CHU shall not be chairman of the Panel at the same time. <u>Mr TO</u> further said that as himself had informed the Clerk of his decision to withdraw his nomination for the chairmanship on 22 November 2019 (LC Paper No CB(4)140/19-20(01) issued on 22 November 2019), the number of valid nominations had reduced to nine as follows: Action

3. M<u>r James TO</u> then called for further nominations. There being no further nomination made by members, <u>Mr TO</u> announced that the nomination procedure closed and the above nine members validly nominated for the chairmanship of the Panel.

4. <u>Ms Tanya CHAN</u> requested that an election forum should be held for candidates to present their election platforms, answer questions from members and make their final responses. <u>Dr KWOK Ka-ki</u> agreed with Ms CHAN that the election forum should comprise three stages. Given the smaller number of candidates nominated for the chairmanship of the Panel as compared to other committees such as the House Committee, he suggested that each candidate should be allotted 10, 20 and 5 minutes for the three stages respectively.

5. Both <u>Mr CHAN Chi-chuen</u> and <u>Mr WU Chi-wai</u> considered that the Panel should take a stringent approach in the election of its Chairman and suggested that reference should be made to the proposed arrangements of election forum considered by the House Committee.

6. <u>Mr James TO</u> ordered that the meeting be suspended for about 20 minutes to facilitate his consideration on the mode of the election forum in consultation with the Clerk.

(The meeting was suspended at 4:52 pm and resumed at 5:24 pm.)

7. Upon resumption of the meeting, <u>Mr James TO</u> invited members to consider two proposed procedural options for the holding of the election forum ("the two options") in the **Appendix** which were distributed for members' consideration at the meeting. <u>Mr TO</u> said that in drawing up the two options, he had taken into account members' views and the relevant options for the holding of election forums considered by various committees including the Finance Committee and the Panel on Security.

8. <u>Mr LAM Cheuk-ting</u> said that the time for candidates to respond to questions from other members was inadequate under either of the two options drawn up by Mr James TO. He suggested that each candidate should be given at least 20 minutes for responding to members' questions and, for those candidates who had fielded questions from a large number of members, 30 to 45 minutes.

9. <u>Mr CHAN Chi-chuen</u> considered that there should be no limit on the number of members to raise questions with the candidates. He also suggested that each candidate could separately be given 10 minutes of "home turf time" to question other candidates and to further elaborate their platforms.

10. Both <u>Mr CHAN Chi-chuen</u> and <u>Mr AU Nok-hin</u> pointed out that, if all members were to ask questions and each was directed at all the nine candidates, the time for each candidate to respond would be 10 minutes so that the total time for response would be 90 minutes. <u>Mr James TO</u> agreed that, in the extreme scenario, the maximum time of the election forum under Option B could be up to 206 minutes.

11. <u>Mr James TO</u> said that in the light of the time constraint, it was not feasible for members to come to a conclusion on the procedure of conducting the election forum during the remainder of the meeting. He directed that the Clerk should brief the Deputy Chairman or the member presiding at the next Panel meeting on the two options and members' views on them, with a view to coming up with an agreement on the procedure for conducting the election forum.

12. The meeting ended at 5:45 pm.
