### I. Election of Chairman and Deputy Chairman

Mr Dennis KWOK, Deputy Chairman of the Panel on Administration of Justice and Legal Services ("the Panel") for the 2018-2019 session, presided over the election of Chairman of the Panel for the 2019-2020 session.

- 2. Mr Dennis KWOK recapitulated that at the previous Panel meeting held on 25 November 2019, the nomination procedure had closed with nine members validly nominated for chairmanship. i.e. Dr Priscilla LEUNG, Mr CHAN Chi-chuen, Mr HUI Chi-fung, Mr Jeremy TAM, Ms Tanya CHAN, Mr Gary FAN, Dr Fernando CHEUNG, Professor Joseph LEE and Dr KWOK Ka-ki. At that meeting, members agreed to hold an election forum for candidates and discussed various procedural options for conducting the forum, including the two options proposed by Mr James TO who presided over the meeting as shown in Appendix of the minutes of that meeting.
- 3. Having regard to members' views expressed at that meeting, Mr Dennis KWOK proposed that Option B proposed by Mr James TO be adopted as the election forum procedure. Members agreed.

#### Election forum for the Chairman election

- 4. In accordance with the adopted election forum procedure, the validly nominated members for chairmanship mentioned in paragraph 2 above, except Dr Fernando CHEUNG who was absent, each spoke for two minutes to elaborate their platforms.
- 5. <u>Ms Tanya CHAN</u> said that, as the present meeting was scheduled to end at 2:30 pm and the remaining time for the meeting would not be sufficient to complete the election forum procedure, she suggested that its question and answer session should not start until the next meeting. <u>Mr CHAN Chi-chuen</u> concurred with Ms CHAN saying that it would only be fair for all candidates to field questions at the same session as they would have equal time for preparing their answers.
- 6. <u>Dr CHIANG Lai-wan</u> said that the election process should be speeded up so that the Panel would be able to proceed with its normal schedule of meetings to consider the various outstanding issues for discussion.
- 7. <u>Mr Dennis KWOK</u> announced that the remainder of the election forum procedure would be carried out at the next meeting.
- 8. The meeting ended at 2:25 pm.
