Re: Concerning the recent decisions of various magistrates on riot-related cases

I am of grave concern over the recent decisions of various magistrates who presided the hearing of riot-related cases.

The decisions taken by the magistrates in question have triggered a public outcry. Citing a couple of examples for reference, in Tam Tak-chi's case, the sentencing of imposing a fine of HK\$3000 is grossly insufficient. Not only did it not achieve any deterrent effect, worse still, it just disseminates a wrong signal to the opposite end: that common assault warrants only a monetary slap on the wrist. Likewise, in the case of the gruesome attack at Ma On Shan MTR station, the couple, Kwong Yiu-man (39) and Chan Hoi-wan (34), were acquitted by the magistrate. Despite the couple's disorderly conduct in a public place which was primarily responsible for escalating their squabbles into Mr Lee Chi-cheung's immolation, the magistrate blatantly erred in acquitting their charges of disorderly conduct in public place both in law and in fact-finding.

I am of serious doubt as to the competency, if not the integrity, of those magistrates concerned. I also wonder if the appellate court has taken any steps to direct or issue any practice guidelines to the courts below as to how they should deal with the sentencing on similar types of cases. If this has not been done, then it begs to question why it isn't the case.
